### Revised publication window for publishing issuers' documents on the Exchange's website

Following the market consultation in relation to the proposed introduction of volatility control mechanism in the securities and derivatives markets and closing auction session in the securities market which was concluded in July 2015, phase one of the closing auction session ("CAS") will be implemented in July 2016.

To align with the revised closing time for trading equity index futures and options upon the implementation of CAS, with effect from 25 July 2016, the publication windows for announcements and notices (other than those specified to be excluded in Main Board Listing Rule 2.07C(4)(a) or GEM Listing Rule 16.18(3)(a)) will be changed as follows:
