

### **CES China 120 Index Daily High-Low Range**




### **MONTHLY HIGHLIGHTS**


- In May 2017, a total of approximately HKD 14 million notional value was transacted with an average daily notional value of HKD 0.7 million for CES China 120 (CES120) Index Futures.
- Open Interest reached HKD 4.6 million notional value at the end of the month.
- CES120 increased by 261 index points (i.e.+4.7%) compared to the previous month-end closing price.
