As introduced in the technical briefings on HKATS & DCASS Upgrade (Upgrade) held in September 2017 and mentioned in the [Information Paper](#) for the Upgrade, a new browser-based front-end application, namely DCASS Online, will be available for Clearing Participants (CPs) to access DCASS. Besides, the existing DCASS Servers and DCASS Terminals will be decommissioned. Moreover, a report retrieval solution will be introduced before the launch of the Upgrade.

To facilitate CPs to prepare for the Upgrade and gain a better understanding of DCASS Online and the report retrieval solution, three briefing sessions will be held on 31 August, 3 and 7 September 2018.

The briefing sessions aim to highlight the basic features of DCASS Online, report retrieval solution, as well as the upcoming activities. Project coordinators of CPs are strongly recommended to nominate one designated staff each from operations and technical respectively to attend the briefing sessions by submitting the online registration form **on or before 27 Aug 2018**.
