References are made to the circulars dated 11 July 2017 (Ref: <u>MDD/002/2017</u>) and 12 October 2017 (Ref: <u>MDD/003/2017</u>) regarding the introduction of the new feed "D-Lite" to be offered to Participants of Hong Kong Futures Exchange Limited and Participants of The Stock Exchange of Hong Kong Limited trading Stock Options (collectively Exchange Participants, or EPs).

We enclose herewith the Connectivity Guide of D-Lite to provide details on the network configuration and guidance to assist enrolled EPs in setting up their networks to connect to HKEX environments for gaining access to D-Lite. The Connectivity Guide covers the D-Lite Readiness Test Environment and the Production Environment. The Readiness Test Environment will be available in late November 2017. We will inform enrolled EPs of the testing arrangements in due course. Connectivity information for gaining access to D-Lite in the HKATS End-to-End Test Environment will be provided in the first quarter of 2018.

Please be reminded that EPs planning to receive market data from D-Lite upon the service rollout in April 2018 should have completed their enrolment by 31 October 2017. To facilitate off-line testing on D-Lite applications by EPs or Application Service Providers (ASPs), an Offline Simulator Tool will be sent to enrolled EPs and ASPs in early November 2017.
