#### Market Making

The Exchange invites applications for the Market Maker permits in the new stock option classes. Market makers will pay a discounted trading tariff of HK\$1.5 for Tier 1 stock option classes upon fulfillment of market making obligations.

## **Pre-launch Arrangements**

The following pre-launch arrangements for the new stock option classes will be implemented on <u>Friday</u>, <u>2 February 2018</u> (i.e. one business day before the Commencement Date):

- a. stock option series of the new stock option classes will be displayed, but not tradable: and
- b. the risk parameter files (RPF), clearing and open interest reports on new stock option classes will be generated.

The purpose of the generation of RPF one business day before the Commencement Date is to assist Participants to estimate the margin requirements for the new stock option classes trading on the Commencement Date.

Please note that the margin requirements estimated using the RPF available after the settlement process on the business day before the Commencement Date may not be the same as the actual amounts required on the Commencement Date. HKEX and its subsidiaries accept no liability whatsoever for any loss or damage arising from or in connection with the use of the information contained in such RPF. Participants who wish to use the above-mentioned RPF are reminded to update the PC-SPAN Organisation Master File. For details, please refer to the relevant Clearing House circular to be issued in due course.

# **Trading Information**

The access codes of information vendors for the new stock option classes will be posted on the HKEX website in due course.

#### Inform Staff and Clients

Exchange Participants are required to notify their staff and all interested clients about the upcoming introduction of new stock option classes and <u>pay special attention that the Option Contract Size will be in multiple board lots of the underlying securities for some of the stock option classes.</u> Please also ensure that the back office systems are ready for a smooth operation.
