Pursuant to the share consolidation timetable issued by Tongda Hong Tai Holdings Limited ("Tongda Hong Tai"), the share consolidation of 10 existing shares of HK\$0.01 each in Tongda Hong Tai into 1 consolidated share of HK\$0.10 each will become effective on 19 March 2024. Shareholders, investors and market participants should read the Tongda Hong Tai's circulars and regulatory announcements in full including the terms and conditions of Tongda Hong Tai's share consolidation in dealing with Tongda Hong Tai's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Tongda Hong Tai's OTP-C temporary stock page (stock code 2931) on 19 March 2024. Calculation of the Adjusted Previous Closing Price will be based on Tongda Hong Tai's closing price on 18 March 2024 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on Tongda Hong Tai's closing price on 18 March 2024, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on Tongda Hong Tai's OTP-C temporary stock page on 19 March 2024 as follows:-
