

COLLATERAL SECURITY BATCH INPUT CONTROL REPORT

Report Name : *Collateral Security Batch Input Control Report*

Purpose : The *Collateral Security Batch Input Control Report* lists out the results of Specific Stock Collateral (SSC) batch files processed. Any errors detected in the files and the input records are given, together with error messages to help identify any irregularities. Total numbers of files rejected, uploaded and processed are also shown.

When a SSC batch file is accepted, the report lists out any errors detected in the detail records together with total number of records and total transfer quantity which are processed, accepted and rejected. When the whole SSC batch file is rejected, it lists out any errors detected in both the control and detail records, together with an error message indicating the whole file being rejected.

Time available : shortly after completion of each SSC batch file validation run scheduled at around 10:00 a.m., 12:45 p.m., 5:00 p.m. and 6:00 p.m. on each Business Day

Frequency : 4 times daily, if applicable
