1. Introduction

Further to the ISO 20022 interface test for Settlement Banks of HKCC & SEOCH (Operations) which was conducted from November 2023 to February 2024, HKCC & SEOCH (Operations) will have Practice Session with each settlement bank as a pre-migration activity to ensure a smooth and successful rollout on 22 Apr 2024. It is **mandatory** for all settlement banks to participate in this Practice Session to fulfill Clearing Houses' requirement.

This Information Package provides settlement banks with the arrangements and scope of the Practice Session. All settlement banks are required to perform necessary setup and preparation prior to the activity.

2. Objective

The objective of this Practice Session is to provide a simulated end-to-end business flow of payments and cash reporting SWIFT messages with production-like timeline for Settlement Banks to confirm their readiness for the rollout. Through participating in Practice Session, settlement banks can:

- verify their system and operation readiness with HKCC & SEOCH (Operations);
- familiarise themselves with ISO 20022 standards in an on-going business; and
- rehearse their migration procedure for the actual system rollout before the Practice Session.

To achieve these objectives, HKCC & SEOCH (Operations) encourages settlement banks to use production-like environment to participate in this Practice Session (e.g. manual intervention which limited to testing only, should be avoided/ minimal).

3. Schedule

The Practice Session will be held during normal business days in following two timeslots and settlement banks are required to participate in either one of them:

- 1) 25 Mar 2024 (Mon) 26 Mar 2024 (Tue)
- 2) 08 Apr 2024 (Mon) 09 Apr 2024 (Tue)

During the Practice Session, HKCC & SEOCH (Operations) will support settlement bank's enquiry from 9:00a.m. until 6:00p.m.

- Production-like end-to-end setup has been tested in this Practice Session to verify proper procedures are in place and have been rehearsed to mimic the actual migration activities for the rollout.
- Ready to continue support on existing BAU contingency arrangement with HKCC & SEOCH (Operations).

8. Severe Weather Arrangement

In case Typhoon Signal No. 8 (or above) / Extreme Conditions is remained at 07:00 or the HK Observatory pre-announced at or before 07:00 that Typhoon Signal No. 8 (or above) will be hoisted at or before 09:00 on the day of Practice Session, the Practice Session will be cancelled and will not be resumed for the rest of that particular day but instead on the immediately following business day accordingly.

In case Typhoon Signal No. 8 (or above) or Extreme Conditions is issued during the Practice Session after 09:00 on the execution day, the Practice Session will be terminated 15 minutes thereafter but instead on the immediately following business day accordingly.
