On 30 March 2012, the Exchange introduced benchmark index futures of BRICS markets as a part of BRICS alliance initiatives. BSE Limited (BSE) and Open Joint Stock Company MICEX-RTS (Moscow Exchange) have recently changed the Sensex index name and company name respectively. Exchange participants are advised to note that, with immediate effect, Sensex Index Futures are renamed to S&P BSE SENSEX Index Futures and the underlying index name is renamed to S&P BSE SENSEX Index. Separately, the company name of Open Joint Stock Company MICEX-RTS is changed to Open Joint Stock Company "Moscow Exchange MICEX-RTS".

Relevant Rules, Regulations and Procedures of the Futures Exchange will be amended and participants will be informed via a separate circular (LSD/26/2013) issued today.

Participants are further advised to note that they will be required to draw your client's attention to the updated disclaimer set forth in Appendix before you facilitate any trades in the above mentioned futures contracts.
