Hong Kong Exchanges and Clearing Limited ("HKEx") plans to upgrade the Hong Kong Futures Automated Trading System ("HKATS") and the Derivatives Clearing and Settlement System ("DCASS") from Release 19.1 to Genium INET Platform. Tentatively, the upgrade to Genium INET Platform for both HKATS and DCASS will be implemented in the fourth quarter of 2013.
