### *Pre-Launch Arrangements*

The following pre-launch arrangements for new stock futures contracts will be implemented on **7 June 2013**:

- a. Underlying stock prices will be broadcasted;
- b. Contract months will be displayed, but not tradable; and
- c. Risk parameter files, clearing and open interest reports will be generated.

### *Trading Information*

The access codes of information vendors for the new stock futures contracts will be posted on the HKEx's website (<http://www.hkex.com.hk>) in due course.

Participants should notify your staff and all interested clients of the details of the new stock futures, in particular that **the contract size of the abovementioned new stock futures will be a multiple of the board lot shares of the underlying stock.** Please ensure that your back office systems are ready for a smooth operation. In addition, all your staff should be fully aware of the above and should exercise caution when dealing with this futures contract and when advising your clients.
