Reference is made to the circular (ref: DMD/112/13) dated 8 July 2013. Hong Kong Exchanges and Clearing Limited (“HKEx”) plans to upgrade the Hong Kong Futures Automated Trading System (“HKATS”) and the Derivatives Clearing and Settlement System (“DCASS”) from Release 19.1 to Genium INET Platform.

In order to facilitate Exchange Participants (“EPs”) to confirm the readiness of their modified OMnet Application Programming Interface (“OAPI”) Programs (if applicable) and trading infrastructures including new CLICK Workstation, Central Gateway (“CG”) connections, Network Gateway (“NG”) connections and SDNet/2 network configurations, HKEx plans to commence Market Rehearsals (“MRs”) in August 2013. All EPs are required to participate in the MRs. Any EPs or OAPI programs who failed to participate and complete the MRs will not be able to access HKATS in the first two weeks after the launch of the Genium INET Platform.

To assist EPs to understand the preparation and execution of the MRs as well as the fallback procedures, HKEx has organized four briefing sessions.
