Reference is made to the circular issued on 14 May 2012 (Ref. No.: RMD/CCRM/002/2012). Subject to the approval of the necessary rule amendments by the Securities and Futures Commission (SFC), HKSCC will introduce Risk Management Reform Measures (Reform Measures) in the third quarter of 2012. The key terms and details of the Reform Measures have been highlighted in the circular (Ref. No.: RMD/CCRM/002/2012) issued on 14 May 2012.

The implementation of the Reform Measures requires enhancements to CCASS and CCMS, including modifications and introduction of new functions and reports as follows:

#### 1. Modification of existing reports and functions

Modifications will be made to the following existing CCASS and CCMS functions and reports:

- a. Collateral Account Balance Enquiry Function
- b. Marks and Collateral Collection Report (CFIPM01) and Intra-day Marks and Collateral Collection Report (CRMIM01)
- c. NCP Marks Projection Report (CRMNP01/02)
- d. Statement of Guarantee Fund Contribution Under CCASS (GFR608)
- e. Collateral Account Balance Report (CCMCA02)
- f. Statement of Collateral Account (CCMDS01)
- g. Participant Collateral Account Movement Report (CCMMV01)
- h. Posting / Collateralisation Result Report (CCMPY01/02)
- i. Statement of Money Ledger (CSEMA08/CSEMS08)
