OCG Enhancement

Exchange Participants (EPs) are requested to note that an enhancement to support order submission and semi-automatic matching for odd lot and special lot orders in OCG will be implemented in the 4th Quarter 2014 along with the Batch 3 OCG rollout. This enhancement will be in the form of optional messages. Existing and future OCG users can select to implement the enhancement to their Broker Supplied System (BSS) or continue to use the manual trade function to report odd lot and special lot transactions. EPs are advised that:

- New versions of the technical documents updated for order submission and semiautomatic matching for odd lot and special lot orders are now available on the HKEx website at OCG project corner under Market Operations – Securities Trading Infrastructure section (http://www.hkex.com.hk/OCG);
- 2) New version of Offline Simulator Package for OCG will be available for download from the Electronic Communication Platform (ECP) from 7 July 2014. The operational procedure for downloading the Simulator Package via ECP is in Attachment_1. The Simulator Package will also be sent to BSS vendors by email. BSS vendors who do not receive the updated Simulator Package by 11 July 2014 should contact us via email to OrionCentralGateway@hkex.com.hk; and
- 3) EPs who have rolled out OCG sessions and plan to implement the new messages for odd lot and special lot order submission and semi-automatic matching are required to complete the relevant new test cases in all the Conformance Tests (i.e. Simulator Test, End-To-End Test, Rollout Test) prior to rollout of the enhancement to their corresponding BSS.

Batch 3 OCG Enrollment

EPs interested to become the Batch 3 users of OCG are required to **enroll on or before 4 July 2014** by submitting the Application Form(s) to HKEx. Application Forms and respective Explanatory Notes of OCG session and related services are posted at OCG project corner (http://www.hkex.com.hk/OCG) on the HKEx website.

The tentative on-boarding schedule for Batch 3 OCG users or those interested to upgrade their BSS for semi-automatic matching is as follows:

Provision of OCG Offline Simulator Packages to EPs	From 7 July 2014 onwards
Submission of Offline Simulator Test Result	11 August 2014
End-to-End Testing	3 rd Quarter 2014
Rollout Test	4 th Quarter 2014
Rollout	4 th Quarter 2014

OCG is for trading only and no securities market data is transmitted from OCG. EPs may choose to receive securities market data directly from HKEx Orion Market Data Platform – Securities Market (OMD-C) or indirectly via information vendors. EPs interested in subscribing to OMD-C are also required to submit the OMD-C Feed Enrolment Form to HKEx on or before 4 July 2014 and refer to technical documents posted at OMD-C project corner to develop their systems.
