Subsequent to the authorization of Hang Seng H-Share Index ETF and Hang Seng Index ETF by the Securities and Futures Commission and the commencement of trading of their HKD counters (Stock Code: 2828 and 2833) on 10 December 2003 and 21 September 2004 respectively, Exchange Participants are requested to note that the RMB counters of the same ETFs (Stock Code: 82828 and 82833) are expected to commence trading on the Exchange and admitted to the list of Designated Securities eligible for short selling on **4 September 2015 (Friday)** and will also be eligible for the RMB Equity Trading Support Facility (TSF). Detail of its trading arrangements ([Attachment 1](#)) is attached for reference.

Securities Market Maker permits have been granted for relevant Exchange Participants to make market for the RMB counters of the ETFs effective the same day. The Securities Market Makers are listed in [Attachment 1](#) for reference. The Securities Market Makers are subject to the market making obligations set out in [Attachment 2](#) of this circular and Securities Market Maker Regulations of the Rules of the Exchange.
