The Panel Member Nomination Committee ("PMNC") is now inviting nominations from Participants of the exchanges and clearing houses of suitable candidates from representatives of market participants and industry experts as members of each of the Consultative Panels for the Board's consideration and approval.

Each of the Consultative Panels consists of two directors of HKEx and eight members selected from representatives of market participants and industry experts. The service term of some members of the Consultative Panels will expire on 1 June 2010. Members will be appointed by the Board in their personal capacity and their terms of appointment will be for a term of three years commencing June 2010.

The Consultative Panels act as the advisory bodies to the Board to provide market expertise and advice on international market trends, the needs of intermediaries, issuers, investors and other market participants, technological challenges and new product opportunities relating to the Cash Market, Derivatives Market and clearing business. It is critical that members appointed to the Consultative Panels should be a member of the senior management in the Participant's business and should have a good knowledge of, and expertise in, the relevant market and business. Meetings will be held as the work of the panel demands and members are expected to attend all the meetings in person or by submission. Appointing an alternate member to attend meetings is not allowed.

A Participant of the exchanges or clearing houses shall be entitled to make only ONE nomination to the respective panel. Nevertheless, Participants carrying out activities in the Cash Market, Derivatives Market as well as clearing business can make one nomination to each of the Consultative Panels.
