The make-up class or examination will be conducted in due course. The course and/or examination will be held as usual if the signal(s) is (are) lowered before 12:00 noon.

香港交易及結算所有限公司(「香港交易所」)擬定此解釋說明以協助 閣下瞭解在提供個人資料予香港交易所及/或其附屬公司(「香港交易所集團」)時的權利及責任,及香港交易所集團將會如何使用或處理該等資料的方式, 懇請閣下細讀此解釋說明。

These Notes are prepared to assist you in understanding your rights and obligations in relation to the supply of personal data by you to Hong Kong Exchanges and Clearing Limited ("HKEx") and/or its subsidiaries (together referred to as the "HKEx group") and the manner in which the HKEx group may use or deal with such data. You are strongly advised to read these Notes carefully.

- 1. 閣下在提交 HKATS 運作、交易程序及規則訓練課程和考試的申請時,需向香港交易所集團提供有關 閣下的個人資料。倘若 閣下未能提供所需的個人資料會影響有關申請將可能被延誤或拒絕。 It is necessary for you to provide the HKEx group with your personal data in connection with your application for enrolment in any one or more parts of the HKATS Operations, Trading Procedures & Rules course and examination. Failure to supply the requested personal data may result in delay or in rejection of the application.
- 2. 倘若 閣下的個人資料有任何變更,亦需即時通知香港交易所集團。
 It is also necessary for you to keep the HKEx group informed of any changes in your personal data.
- 3. 香港交易所集團將於香港證券及期貨市場使用 閣下所提供的個人資料以執行他們的職能。
