1. We hereby authorise our below-named Bank ("the Bank") to accept and effect transfers in accordance with Electronic Payment Instructions ("EPIs" and "EPI" shall be construed accordingly), being debit instructions to effect transfers from our bank account ("the Account") set out below from time to time presented to the Bank by Hong Kong Interbank Clearing Limited.
