 - a. Direct Debit Authorisation 直接扣賬授權

I/We hereby authorise my/our below-named Bank ("the Bank") to effect transfers from my/our United States Dollar ("USD") bank account ("the Account") set out below to the USD bank accounts of Hong Kong Securities Clearing Company Limited ("HKSCC") specified below in accordance with Direct Debit Instructions ("DDIs" and "DDI" shall be construed accordingly) presented to the Bank by HKSCC via Hong Kong Interbank Clearing Limited ("HKICL") from time to time.
