## <u>Project Schedule of Securities and Derivatives Network (SDNet/2) – Phase 1 MDS/IIS Network Migration</u>

Our notice issued on 4 November 2011 (MDD/11/2148) regarding the upgrade of the Securities and Derivatives Network (SDNet) to SDNet/2 refers please.

Phase 1 of the upgrade project, which is to migrate MDS/IIS connections to SDNet/2, is progressing on schedule. Please note the tentative detailed schedule as provided in the table below:

## **Pre-Market Rehearsal Arrangement**

Please work with your selected network vendor(s) closely to make sure that your SDNet/2 lines will be ready for the Market Rehearsal on 14 April 2012. To facilitate successful completion of the SDNet/2 router installation by the network vendors, HKEx offers a connectivity test session to IVs upon the installation of their SDNet/2 router(s). The connectivity test will be arranged for Saturday and the test details will be provided to individual IVs by email in due course.

## **Stabilisation Period**

According to the project plan, SDNet/2 will take over as the production network for MDS and IIS after the Post Release Test on 19 May 2012 thereupon SDNet/1 will no longer operate for MDS and IIS but will only stand by for the first week (i.e. the stabilisation period) after that. In the unlikely event that SDNet/2 encountered unrecoverable error during the stabilisation period, HKEx might decide to fall back to SDNet/1 as a contingency measures. IVs are highly recommended to retain your SDNet/1 equipment until the end of the stabilisation period so that you can restore your SDNet/1 connection when necessary.
