Post Release Test for SDNet/2 Network Migration

Our notice issued on 2 March 2012 (MDD/12/263) regarding the project schedule of the Securities and Derivatives Network (SDNet/2) refers please.

Following the successful completion of Market Rehearsal held on 14 April 2012, the production cutover will be conducted as per the original schedule below:

Activity	Mandatory/ Optional	Schedule
Post Release Test 1 – for IIS / MDF*	Mandatory	12 May 2012 (Saturday)
Post Release Test 2 – for MDF3.8	Mandatory	19 May 2012(Saturday)
Production Cutover	-	21 May 2011 (Monday)
Stabilisation Period	-	21 May – 2 June 2012

IVs are required to demonstrate the readiness of their SDNet/2 circuits for production in the Post Release Test (PRT) and are therefore expected to have proper network setting to enable them to do so. For example, IVs with Live-Live connection have to connect both lines to MDS host whereas IVs with Live-Backup connection must ensure their backup line can take over when the primary line fails. In addition, in order to ensure a smooth cutover, IVs are requested to provide all necessary support, including on-site access permission, network and application support, etc. to its SDNet/2 Vendors on the PRT day for rectification of problems encountered during the PRT.

Please complete and return the enclosed Test Participation Form by 9 May 2012 (Wednesday). Upon the completion of the Post Release Test, you are required to submit the duly completed Test Result Confirmation Form as enclosed no later than 4:00 pm on the test date.

Lastly, in the rare event of severe SDNet/2 problem occurring during the Stabilisation Period (21 May to 2 June 2012), HKEx might decide to fall back to SDNet/1 for providing connection service to IVs. IVs should retain their SDNet/1 equipment during the said period to stand by for the fallback arrangement. Collection of SDNet/1 equipment will then take place between 2 June and 31 July 2012. The SDNet/1 Vendor, PCCW, will contact individual IVs directly for the collection arrangement.
