## (1) Market Rehearsals for Migration of MDS3.8 to Tseung Kwan O Data Centre and (2) Regular AMS/3.8 Rehearsal on 6 October 2012 ("the Rehearsal")

Please note that the construction work of the HKEx's Next Generation Data Centre at Tseung Kwan O (TKODC) to host all the cash, derivative and clearing systems is near completion. The security trading applications including AMS/3.8, MDS/3.8 and related systems ("the systems") will be the first systems to be relocated to the TKO Data Centre.

To enable a smooth transition of cash market operations to TKODC, two Market Rehearsals (MRs) will be conducted on **22 September and 6 October 2012** as the final verification of the market readiness before the cutover of the systems to the new data centre.

The first MR on 22 September will focus on the normal operation. The second MR on 6 October will cover two modes of system recovery under emergency situations. The first mode of system recovery is "Re-start AMS/3.8 Primary System after system failure during the Order Input Period of the Pre-opening Session". The second mode of system recovery is "Re-start AMS/3.8 Backup System after system failure during the Continuous Trading Session".

All IVs are requested to participate in the MRs to verify their connectivity to the MDS/3.8 host at the TKODC. The second MR on 6 October 2012 which also covers the Rehearsal is mandatory for IVs.
