HKEx Orion Market Data Platform Phase 1a (OMD-C) – Updated Materials

Please see below the latest updates on the following OMD-C materials:

(1) Interface Specification

OMD Interface specifications for Securities Market & Index Datafeed Products (version 1.2) is enclosed (via email only) for your reference.

(2) On-boarding Tool and canned data

The OMD-C On-boarding Tool which contains the user guide, RTS simulator, Multicast Injector, XDP Dump and canned data has been updated to version 1.1.1 with the following major changes and enhancements:

- i. Flexibility to run the tool in a different machine from the client’s feed handler or in the same machine.
- ii. Packet timestamp with correct precision
- iii. Correct RTS logon response
- iv. Wider variety of market data provided in the canned data to better facilitate client’s functional and volume tests

The On-boarding Tool version 1.1.1 is sent as an enclosure to this letter by post to each Direct Connection Securities Market Data Vendor and End-User.

Note: Clients who attended the Vendor seminar on 18 or 19 Oct 2012 (& English session on 26 Oct 2012) and collected the DVD for On-boarding Tool version 1.1 should note that version 1.1 is now an obsolete version. Please use version 1.1.1 for your testing.

(3) Connectivity Guide

An updated OMD-C Connectivity Guide (version 1.1) is also enclosed (via email only). In addition to several updates on the channel assignment for each OMD-C datafeed products, this latest version of the Connectivity Guide is enriched with useful guidelines on setting up SDNet/2 and HSN connection to OMD to facilitate client’s network arrangement.
