# <u>Technical Refresh for HKEX Orion Market Data Platform – Securities Market (OMD-C)</u> and Mainland Market Data Hub (MMDH)

Please be informed that there will be a Technical Refresh on OMD-C and MMDH ("Technical Refresh") with the details below:

#### 1. Scope

This Technical Refresh includes hardware upgrade, Operating System (OS) upgrade and software update in OMD-C and MMDH.

#### 2. Client Impact

There is **no interface change** and therefore this Technical Refresh should be functionally transparent to OMD-C and MMDH Clients.

However, to strengthen the security, password requirement for MMDH will be enhanced as follows:

MMDH Password Requirement	Existing	New	
Length of password	At least 8 characters Maximum 20 characters	At least 16 characters Maximum 20 characters	
Complexity of password	Alphanumeric	Must contain a combination of:  - Upper case letter  - Lower case letter  - Numeric  - Special character	
Password reset frequency	Password cannot be changed more than once within 24 hours	No restriction	



We enclose the following technical documents of OMD-C MMDH which have been updated to reflect the aforesaid enhancement in the password requirement and other housekeeping changes. Please refer to the change history for the update, which has also been highlighted with "|" on the right margin in the document for your easy reference.

To facilitate your preparation, MMDH On-boarding tool will be provided to registered technical contacts. MMDH Clients can make use of the tool to conduct off-line testing on the new password requirement. MMDH Clients should make appropriate changes to ensure their system is compatible to the new password requirement before joining the Market Rehearsal.
