### Introduction of New Spread Table Code for Inline Warrants in HKEX Orion Market Data Platform – Securities Market (OMD-C) and Mainland Market Data Hub (MMDH)

Refer the enclosed Participant Circular from the Stock Exchange of Hong Kong Limited (SEHK) on the Rejection for Inline Warrants Order and Trade at Price Above \$1.00 (Ref: CT/109/19), a new spread table code "04" will be introduced for Inline Warrants from <u>10 February 2020 (Monday)</u>. This new spread table code refers to the same spread table as specified in <u>Part A of Spread Table under</u> <u>Second Schedule of Rules of the Exchanges</u> up to and including trade price at HK\$1.00.

OMD-C and MMDH Clients can refer to the data field "SpreadTableCode" of Security Definition (11) message to identify the spread table of a security. Enclosed are the updated OMD-C Interface Specification (version 1.28) and OMD-C MMDH Interface Specification (version 1.27). The change can be found in the change history and also been highlighted with "|" on the right margin in the document for your easy reference.

Clients and ISVs please review your systems, including downstream, to evaluate if any adjustment is required. Indirect Connection Clients are also recommended to confirm with their data vendors and/or ASPs that the necessary arrangement is in place to handle the new spread table code properly. It is recommended that Clients' system should be made ready to handle the additional of a new spread table code with different tick sizes, if required in the future.

#### **Testing Facilities**

To facilitate Clients and ISVs to test the new spread table code, OMD-C End-to-End (E2E) test session and a weekend practice session will be arranged.

Also, a canned data set will be available to OMD-C and MMDH Clients for off-line testing.
