Introduction of New Spread Table Code for Exchange Traded Funds and Leveraged and Inverse Products in HKEX Orion Market Data Platform – Securities Market (OMD-C) and Mainland Market Data Hub (MMDH)

Please refer to the enclosed Participant Circular from the Stock Exchange of Hong Kong Limited (SEHK) on the Introduction of new spread table and market making obligations for Exchange Traded Funds and Leveraged and Inverse Products (ETFs and L&I Products) (Ref: <u>ETP/004/19</u>), an introduction of new spread table (Part D) with code "05" is tentatively scheduled for **Late February 2020**, **subject to regulatory approval**. A separate Participant Circular will be issued by SEHK for the relevant rule amendments including the updated <u>Spread Table under Second Schedule of Rules of the Exchanges</u>.

OMD-C and MMDH Clients can refer to the data field "SpreadTableCode" of Security Definition (11) message to identify the spread table of a security. Enclosed are the updated OMD-C Interface Specification (version 1.30) and OMD-C MMDH Interface Specification (version 1.29). The changes are listed in the change history and have also been highlighted with "|" on the right margin in the document.

Clients and ISVs please review your systems, including downstream, to evaluate if any adjustment is required for the new spread table code with new tick intervals. Indirect Connection Clients are also recommended to confirm with their data vendors and/or ASPs that the necessary arrangement is in place.
