**Arrangement of the Introduction of New Stock Futures Contract and Stock Options Class on NetEase, Inc. in HKEX Orion Market Data Platform – Derivatives Market (OMD-D)**

Hong Kong Exchanges and Clearing Limited (HKEX) announced the introduction of stock futures contract and stock options class on NetEase, Inc. (“NetEase Futures and Options”). Subject to the successful listing of NetEase on **11 June 2020 (Thursday)**, trading of NetEase Futures and Options will commence on the same day.

**b) Pre-launch Arrangement**

Due to the pre-launch arrangement on 10 June 2020, NetEase Futures and Options may be found in some OMD-D messages, but they will not be tradable on that day.
