Arrangement in HKEX Orion Market Data Platform – Derivatives Market (OMD-D) for Enhancements for Volatility Control Mechanism ("VCM") and Pre-Market Opening Session ("POS") in the Derivatives Market

With reference to our Client Notice issued on 11 December 2020 (Our Ref: MDD/20/1034) regarding Planned Activities / Initiatives In Relation to Market Data Systems for 2021, as well as the enclosed Participant Circular from Hong Kong Futures Exchange Limited ("HKFE") (Ref: MO/DT/003/21), HKFE plans to enhance the Volatility Control Mechanism (VCM) and Pre-Market Opening Session (POS) in the Derivatives Market in Q2 2021 tentatively, subject to the market readiness.

The enhancement on VCM will allow multiple triggers of VCM per trading session. In OMD-D, the Market Status (320) and Market Alert (323) messages for VCM trigger will be disseminated at every VCM occurrence correspondingly. For the enhancement on POS, a random cutoff mechanism will be introduced to the Pre-Opening session and the Pre-Open Allocation session. In OMD-D, the corresponding Market Status (320) message will be disseminated according to the random cutoff. Nevertheless, there is no system interface change and no new message to be introduced in OMD-D for the aforesaid enhancements.
