Arrangement in HKEX Orion Market Data Platform – Derivatives Market ("OMD-D") for (1) Introduction of Additional Matching Engines in HKEX Derivatives Trading System ("HKATS"); and (2) Update on Implementation Schedule for OMD-D Resilience Enhancement

## 1. Arrangement in OMD-D for Introduction of Additional Matching Engines in HKATS

With reference to our Client Notice issued on 11 December 2020 (Our Ref: <a href="MDD/20/1034">MDD/20/1034</a>), as well as the enclosed Participant Circular from Hong Kong Exchanges and Clearing Limited (Ref: <a href="MO/DT/108/21">MO/DT/108/21</a>), additional two matching engines will be introduced in HKEX Derivatives Trading System ("HKATS"). Accordingly, additional partition and multicast channels will be introduced in OMD-D together with an update of some existing multicast channels.

The OMD-D Developers Guide (version 1.23) and OMD-D Connectivity Guide (version 1.16) are updated to provide the details. All document changes are summarised in the change history and highlighted with "|" on the right margin in the documents.

This change will be implemented together with the OMD-D Resilience Enhancement with details below.

## 2. Implementation Schedule and Update Schedule for OMD-D Resilience Enhancement

With reference to our Client Notices on 18 March 2021 (Our Ref: MDD/21/232), 7 April 2021 (Our Ref: MDD/21/282) and 10 May 2021 (Our Ref: MDD/21/384), to reduce Clients' testing effort, the OMD-D resilience enhancement will be arranged to take place together with the introduction of additional matching engines in HKATS.
