Subject: HONG KONG INVESTOR IDENTIFICATION REGIME (HKIDR) - COMMENCEMENT

OF END-TO-END (E2E) TEST

With reference to the Exchange circulars (Ref. No.: CT/021/22 and CT/026/22), please note that E2E Test Session for HKIDR (including two new features of the Orion Central Gateway – Securities Market) is confirmed to be arranged from **16 May 2022 to 15 July 2022**. All Relevant Regulated Intermediaries (RRIs)² are required to participate in the E2E Test Session and are reminded to refer to the published test packages and connectivity guide to get ready for the mandatory testing.

After completion of the E2E Test Session, RRIs should submit positive testing confirmation reply to the SFC (for BCAN-CID Mapping File and reporting forms submission) and HKEX (for BCAN tagging in OTP-C³ which is applicable to Exchange Participants (EPs) only) respectively by **15 July 2022**. Market Rehearsals (MR) will be further arranged in Q3 2022 for RRIs to verify their readiness before the launch of the HKIDR. Details of the MR will be announced in due course.

Templates for Reporting Forms

To facilitate the submission of various reporting forms under the HKIDR, templates of the five reporting forms are now published on the HKIDR <u>web corner</u> for reference. RRIs can either use the templates or refer to Section 3 of the <u>File Interface Specifications</u> when preparing the reporting forms. For the avoidance of doubt, a template for the BCAN-CID Mapping File will not be provided, and RRIs should refer to Section 2 of the <u>File Interface Specifications</u> when preparing the BCAN-CID Mapping File.

Notification of Testing Line by Non-EP RRIs Using ECP Secure File Transfer Protocol (SFTP) Interface for E2E Test Session

Further to guidance provided in the previous circular on the use of ECP (SFTP) Interface by non-EP RRIs, non-EP RRIs who intend to make use of the ECP (SFTP) interface for the E2E Test Session should complete the "Notification of Testing Line" form after testing line installation, and submit to HKEX via E2E ECP Web Interface starting from 16 May 2022.
