Following the successful completion of HSN Production Cutover Phase 2 on 5 October 2019, Phase 3 of HSN Production Cutover will take place on 12 October 2019.

Subject to successful completion of Phase 3 of HSN Production Cutover, HSN subscribers **MUST** perform HSN Production Cutover Verification Tests in the morning of 12 October 2019 (between 9 a.m. to 12:10 p.m.) for verifying the HSN connections after Phase 3 of HSN Production Cutover. HSN subscribers are required to declare the readiness for the Hardware Replacement after Phase 3 of HSN Production Cutover.

3. Arrangement of unplanned disruptions

- Typhoon, Extreme Conditions and Rainstorm Arrangements on 12 October 2019

When Tropical Storm Warning Signal No. 8 (or above) or the Black Rainstorm Warning Signal is hoisted or Extreme Conditions is announced, the following arrangements will apply:

Condition	Arrangement
If Tropical Storm Warning Signal No. 8 or above or Extreme Conditions or Black Rainstorm Warning is issued/ announced or continues to be in force anytime from 7:00a.m. to before 9:00a.m.	HSN Production Cutover Verification Test will be cancelled and will not be resumed for the rest of the day.
If Tropical Storm Warning Signal No. 8 or above or Extreme Conditions is issued on or after 9:00a.m.	HSN Production Cutover Verification Test will be terminated 15 minutes thereafter.
If Black Rainstorm Warning Signal is issued on or after 9:00a.m.	HSN Production Cutover Verification Test will continue until completion.

- Under exceptional circumstances, such as severe transportation incident...etc., HKEX-Hosting will inform the contact(s) as provided by HSN subscribers on their submitted "Participation Form of HSN Production Cutover Verification Test" by email and/or SMS as soon as possible if the HSN Production Cutover Verification Test would be cancelled.

4. Please be reminded of the following schedule of other activities of Hardware Replacement:

Saturday, 12 October 2019	HSN Production Cutover Phase 3: replace the Secondary HSN network switches
Sunday, 13 October 2019 to Friday, 25 October 2019 (Tentative)	Stabilisation period

5. Important Reminder

- In the period between the completion of HSN Production Cutover Phase 2 and before starting of Phase 3, as the Primary HSN network switches have been replaced and are estimated to have around 1 microsecond enhancement over the Secondary HSN network switches (to-be-replaced in Phase 3), HSN subscribers may experience a latency difference between the Primary and Secondary HSN, for example on Orion Market Data feeds disseminated.
- Due to the Hardware Replacement, new HSN provisioning and HSN reconfiguration services will NOT be offered from the successful completion of HSN Readiness Test to the end of stabilisation period, i.e. from 23 September to 25 October 2019 (both dates inclusive), tentatively.
- All messages disseminated from Market Data Systems during the test period should be treated as non-production data and have to be cleaned up afterwards.
- Due to the preparation work of Phase 3 of HSN Production Cutover, there would be service interruption on the HSN connections between 6:00 a.m. to 8:00 a.m. on 12 October 2019.
- The replacement of the network switches supporting the NTP time-service will be rescheduled to a later date. HKEX-Hosting will inform the subscribers about the new schedule in due course.
- In the unlikely event that a roll back is required, the original firewalls and network switches will be re-instated. HKEX-Hosting will inform HSN subscribers by email and/or SMS as soon as possible.
