1 Overview

This document serves as a reference guide for Exchange Participants (EPs) on the maintenance of Self-Match Prevention (SMP) ID for Hong Kong Derivatives Market.

To support the trading with Self-Match Prevention (SMP) Service (ID-based) in Hong Kong derivatives market, EPs can apply for the use of SMP by submitting Application for the Use and Maintenance of Self-Match Prevention (SMP) ID in Derivatives Market ("SMP ID Maintenance Form")/ Application for the Use of Existing Self-Match Prevention (SMP) ID in Derivatives Market ("Use of Existing SMP ID Form") via the Electronic Communication Platform (ECP) (https://ecp2.hkex.com.hk/) facility provided by HKEX.

1.1 Summary of Interface Files and Operation Flow

1.2 File Submission and Distribution Channel

EPs are allowed to submit "SMP ID Maintenance Form" / "Use of Existing SMP ID Form" interface files on every Hong Kong Derivatives Market trading day² except Holiday Trading Days within submission hours (refer to section 2.1) by the following channels:

- 1. ECP Web Interface via Internet; or
- 2. ECP SFTP interface via Security and Derivatives Network/2 (SDNet/2) or HKEX Service Network (HSN)

If there are multiple submissions throughout the day, all the submissions will be processed by the system according to the ascending order of the submission time in general.

Please refer to "ECP 2.0 User Guide" for the details of file submission and download via ECP.

¹ EPs submit the Forms beyond this timeline, it will be considered as next day submission.

² In case trading on a scheduled Hong Kong Derivatives Market trading day is suspended due to severe weather conditions, EPs are still allowed to submit the Forms according to the schedule specified in section 1.1 of this specification.

1.3 Data Format Definition

Data format commonly used in this document are as follows:

Format/Type	Synopsis
X(n)	Alphanumeric data of <i>n</i> bytes. Left-justified with trailing spaces unless otherwise stated.
9(n)	Numeric field with maximum of <i>n</i> digits. No leading zeroes. Right-justified and fill up with spaces if less than <i>n</i> digits unless otherwise stated.
YYYYMMDD	Date field, where YYYY stands for the year, MM stands for the month, and DD stands for the day, e.g. 20210401 for 1 April 2021.
HH:MM:SS	Time field, where HH stands for hour, MM stands for minute, and SS stands for second, e.g. 15:23:04, 09:20:23.

2 File Specification

2.1 SMP ID Maintenance Form

2.1.1 Description

Primary EP³ can submit the "SMP ID Maintenace Form" to:

- create SMP ID for a HKATS Customer Code;
- terminate SMP ID;
- change SMP Instruction;
- share SMP ID with additional HKATS Customer Code (same EP or different EP); or
- remove SMP ID sharing from additional HKATS Customer Code (same EP or different EP).

EPs are allowed to submit "SMP ID Maintenance Form" on every Hong Kong Derivatives Market trading day except Holiday Trading Days within submission hours. Multiple submissions are allowed and all the submissions will be processed by HKEX according to the ascending order of the submission time in general.

Operations:

1. For Creation of SMP ID:

- a. EP can raise request to create a new SMP ID for a HKATS Customer Code.
- b. SMP ID will be generated by HKEX. EP who raises the creation request will be treated as Primary EP of the SMP ID.
- c. After the creation request is completed, the Primary EP can submit orders with the SMP ID next trading day.

2. For Sharing of SMP ID:

- a. Only Primary EP can raise request to share its SMP ID with another HKATS Customer Code (same EP or different EP).
- b. Each "SMP ID Maintenance Form" can raise a request to share an existing SMP ID with one HKATS Customer Code only. It needs to submit multiple requests in order to share the existing SMP ID with multiple HKATS Customer Codes (same EP or different EP).
- c. For each sharing request, Primary EP or Additional EP4 should submit the corresponding "Use of Existing SMP ID Form" to apply for using an existing SMP ID. HKEX will process the sharing request only when the "SMP ID Maintenance Form" mentioned in 2b and "Use of Existing SMP ID Form" in 2c are well received. If the "Use of Existing SMP ID Form" is not received within 7 calendar days, the sharing request will be expired and will not be processed.
- d. After successful sharing of the existing SMP ID, the Primary EP and the Additional EP or its clients can submit orders with the SMP ID on the next trading day. Primary EP, Additional EP, if any, and other relevant Additional EPs of the same SMP ID will be notified via SMP ID Full Image Report and SMP ID Delta Change Report.

³ Primary EP means an EP who initiates the request to create an SMP ID under one HKATS Customer Code 4 Additional EP refers to EP, which is not the Primary EP, who applies for the use of an existing SMP ID

3. For Removal of SMP ID Sharing:

- a. Only Primary EP can raise request to remove SMP ID Sharing from another HKATS Customer Code.
- b. Application from the Additional EP is not required.
- c. After the request of removing SMP ID sharing with another HKATS Customer Code is completed, the corresponding Additional EP or its clients can no longer use such SMP ID from the next trading day. Primary EP, Additional EP, if any, and other relevant Additional EPs of the same SMP ID will be notified via SMP ID Full Image Report and SMP ID Delta Change Report.

4. For Termination of SMP ID:

- a. Only Primary EP can raise request to terminate its managed SMP ID.
- b. Termination of SMP ID will also remove all the SMP ID Sharing.
- c. After the termination request is completed, the Primary EP and all Additional EPs or their clients can no longer use such SMP ID from the next trading day. Primary EP and all Additional EPs will be notified of the removal of such SMP ID via SMP ID Full Image Report and SMP ID Delta Change Report.

5. Change of SMP Instruction:

- Only Primary EP can raise request to change the SMP Instruction of its managed SMP ID.
- b. After the change request is completed, new SMP Instruction will be effective for such SMP ID on the next trading day.

Once the "SMP ID Maintenance Form" is being processed by HKEX, the processing status will be included in the SMP File Submission Status Report (Please refer to Section 2.3). SMP File Submission Status Report will be distributed to EP on a daily basis. EP can keep track of the progress of their submitted requests via this report. If it fails to process a request, EP can check the rejection code from the report and re-submit the corrected "SMP ID Maintenance Form" again. If the Form has been processed successfully, the change will be reflected in SMP ID Full Image Report and SMP ID Delta Change Report.

All files will be removed from the submission folder in ECP after system cleanup.

Note:

- 1. Each Form can raise one SMP maintenance action only.
- 2. All requests will be reviewed by HKEX before execution.
- 3. The request will be treated as error and rejected under the following conditions, e.g.:
 - a. PDF format is corrupted (e.g. missing fillable form inside the PDF file)
 - b. Mandatory field values are missing.
 - c. EP who uploads the form is not the Primary EP of the SMP ID (except SMP ID Creation).
 - d. SMP ID doesn't exist in System.
 - e. Primary / Another HKATS Customer Code doesn't exist in System.
 - f. Same request had been submitted and pending for execution by HKEX (except SMP ID Creation).

Please refer to Appendix A.1 for the list of rejection code.

2.2 Use of Existing SMP ID Form

2.2.1 Description

The "Use of Existing SMP ID Form" is used by Primary EP or Additional EP or on behalf of its clients to raise a request of using an existing SMP ID.

If Primary EP submits a "SMP ID Maintenance Form" to request for sharing a SMP ID, if the sharing is not for HKATS Customer Code under Primary EP, Primary EP should notify the target Additional EP to provide an application for using such SMP ID.

Additional EP should submit the "Use of Existing SMP ID Form" on Hong Kong Derivatives Market trading day except Holiday Trading Days within submission hours for using the SMP ID.

All files will be removed from the submission folder in ECP after system cleanup.

 - a. The request had been processed or rejected.
 - b. No SMP ID Sharing request from Primary EP matching with this application for 7 calendar days.

- 2. The application will be treated as error under the following conditions, e.g.:
 - a. PDF format is corrupted (e.g. missing fillable form inside the PDF file)
 - b. Mandatory field values are missing.
 - c. SMP ID doesn't exist in System.
 - d. HKATS Customer Code under the Primary \mbox{EP} / Additional \mbox{EP} doesn't exist in System.
 - e. $\,$ HKATS Customer Code under the Primary EP / Additional EP doesn't match with the SMP ID.
 - f. Same application request had been submitted to HKEX.

2.3 SMP File Submission Status Report

2.3.1 Description

The SMP File Submission Status Report contains the latest status of the "SMP ID Maintenance Form" / "Use of Existing SMP ID Form" submitted by EP. Completed and failed requests would be shown on Trading Day T; while outstanding request will be kept until it turns completed or failed.

SMP File Submission Status Report is distributed to the respective EPs at 7:30am on each Hong Kong Derivatives Market trading day. EPs without outstanding request will not receive this file.

EPs can keep track of the status of their submissions through this report. If there is any error when processing the files, EP can check the rejection code from the report and resubmit the corrected files again.

This report includes the following information:

- SMP IDs managed by the EP
- SMP IDs shared by the other HKATS Customer Codes
- Primary HKATS Customer Code of the SMP ID
- Full list of Primary HKATS Customer Code and additional HKATS Customer Codes sharing the SMP ID

Individual Full Image Report is distributed to the respective EPs at 7:30am on each Hong Kong Derivatives Market trading day.

EPs are reminded to check the records in this file to ensure that they are trading using the most updated SMP ID records.

The SMP ID Delta Change Report highlights the changes of SMP ID and SMP ID sharing related to an EP or its clients.

If the SMP ID is managed by this EP, or the SMP ID is managed by another other EP and is shared with this EP, the following changes will be covered in this report:

- Creation of SMP ID
- Termination of SMP ID
- Sharing of SMP ID
- Removal of SMP ID Sharing
- Change of SMP Instruction
- Suspension of SMP ID
- Resumption of SMP ID

Individual SMP ID Delta Report is distributed to the respective EPs at 7:30am on each Hong Kong Derivatives Market trading day.

EP s are reminded to check the records in this file to ensure that they are trading with the most updated SMP ID records.
