2. Introduction

This document describes the binary interface of the HKEX Orion Central Gateway - Securities Market (“OCG-C”), the market access platform for the Securities market.

The OCG-C provides a centralized, highly resilient, low latency, flexible and scalable platform for all Exchange Participants (EPs) to access HKEX securities trading system (“OTP-C”) for order, quote and trade management.

The terminology used, message format, message flow and event models described throughout this document are similar to that of FIX 5.0 SP2 protocol specifications, where applicable, with some specific and explicit changes for performance and adaptability reasons.

HKEX and/or its subsidiaries endeavour to ensure the accuracy and reliability of the information provided, but do not guarantee its accuracy and reliability and accept no liability (whether in tort or contract or otherwise) for any loss or damage arising from any inaccuracy or omission or from any decision, action or non-action based on or in reliance upon information contained in this document.

No part of this document may be copied, distributed, transmitted, transcribed, stored in a retrieval system, translated into any human or computer language, or disclosed to third parties without written permission from HKEX.

HKEX reserves the right to amend any details in this document at any time, without notice.

3. Connectivity

3.1 Session

Exchange Participants connect their broker supplied systems (“BSS” or “Client”) to the OCG-C via subscription to one or more OCG-C “Session”. This connection is a standard TCP/IP point-to-point connection.

EPs are expected to pre-register at least one IP address using which a client from their end would establish a Trading Session with the OCG-C. For backup purposes EPs can optionally pre-register up to 3 additional IP addresses for each session.

A session can be established from only one of the pre-registered IP addresses for that session. EPs can pre-register any given IP address for more than one session such that the same BSS can be used to connect to OCG-C through one or more sessions.

3.2 Comp ID

The client should use the Comp ID (a unique session identifier) provided by HKEX for each session in order to connect to the OCG-C. A single client may have multiple connections to the OCG-C i.e., multiple Binary sessions, each with its own Comp ID.

The messages sent to the OCG-C should contain the Comp ID assigned to the client in the field Comp ID in the header section.

3.3 IP Address and Port Numbers

The client that wishes to connect to the OCG-C will first connect to the Lookup Service by using one of the four (4) Lookup Service IP-port pairs published by HKEX. Two of these connection points represent the primary site Lookup Service and the other two represent the backup site Lookup Service

HKEX will provide these four (4) IP address and Port number pairs through a separate medium.

3.4 Lookup Service

The client connecting to the OCG-C via the binary protocol must first connect to a predefined Lookup Service and request for a connection point (an IP address and port) to the binary trading gateway.

The client should attempt the Lookup Service connections in the following order:

- Primary site primary Lookup Service
- Primary site mirror Lookup Service
- Backup site primary Lookup Service
- Backup site mirror Lookup Service
- Cycle back to primary site primary Lookup Service

The backup site Lookup Service will not be open unless there is a failover.

The client can request for the Lookup Service via the Lookup Request message by specifying the Type of Service and the Protocol Type the client wish to connect to.

The Lookup Request must originate from an IP address allowed (i.e., one of the 4 IP addresses as mentioned in [Section 3.1](#)) for the Comp ID specified in the Lookup Request.

The Lookup Service will respond to a Lookup Request with a Lookup Response. If the Lookup Request is accepted, the Lookup Service will deliver two IP Address & Port pairs (one for the primary and one for the mirror) of the OCG-C trading service to the client via the Lookup Response. The client is expected to always attempt the primary service first.

In the case where the Lookup Request is rejected, the Lookup Service will reply with a Lookup Response with Lookup Status set to Rejected (1). The reason for rejection of the Lookup Request will be reflected in the Lookup Reject Code field.

If Lookup Service can't be reached for reasons or the service rejects the request, client should observe a delay of 5 seconds before re-attempting.

3.5 Encryption

The binary protocol expects Password and New Password be encrypted when they are sent in the Logon message from the client to the OCG-C.

To encrypt the password, the client is expected to use a 2048-bit RSA ([http://en.wikipedia.org/wiki/RSA_\(algorithm\)](http://en.wikipedia.org/wiki/RSA_(algorithm))) public key circulated (through a different medium) by HKEX. The binary output of the RSA encryption must be represented in Big Endian format (Padding scheme is PKCS #1 or OAEP) and then converted to an alphanumeric value by means of standard base-64 encoding (<http://en.wikipedia.org/wiki/Base64>) when communicating with the OCG-C.

HKEX may periodically renew the public key used by the client and after a public key renewal; a client may continue to use the old key for a limited grace period. Both keys may be used during this time.

3.6 Password

The client should specify their password in the Password field of the Logon message. This password must be in encrypted form. For security reasons, the client is expected to prefix the login time, in UTC format (YYYYMMDDHHMMSS), to the password before encryption. The client must ensure that login time is in accurate UTC. The OCG-C will extract the login time prefix from the decrypted password string and validate that it is within the configured tolerance of the actual current time. A Logon request that fails this validation is rejected by the OCG-C.

The status of the password (i.e. whether it is accepted or rejected) will be specified in the Session Status field of the Logon sent by the OCG-C to confirm the establishment of a binary connection.

Repeated failures in password validation may force HKEX to lock the client; the EP is expected to contact HKEX to unlock the client and reset the password.

3.7 Change Password

Each new Comp ID will be assigned a password on registration. The client is expected to change the password upon first logon whenever a password is (re)issued by HKEX.

Password change request can be made together with Logon request. The client should specify the encrypted new password in the New Password field and the current encrypted password in the Password field.

The new password must comply with HKEX password policy (refer to Appendix [A](#)). The status of the new password (i.e. whether it is accepted or rejected) will be specified in the Session Status field of the Logon sent by the OCG-C to confirm the establishment of a binary connection. The new password will, if accepted, be effective for subsequent logins.

The client is required to change the password periodically. HKEX will set expiry duration for the password without exemption; a reminder will be sent indicating that the password is to about to expire, through the Text field in the Logon response. Once the password has expired for a client, that client will not be allowed to logon, and the EP is required to contact HKEX to unlock and reset the client password.

3.8 Failure and Recovery

The system has been designed with fault tolerance and disaster recovery technology that ensures that trading should continue in the unlikely event of a process or server outage.

If the client is unexpectedly disconnected from the Primary OCG-C, it should attempt to re-connect to the Primary OCG-C before attempting to connect to the Secondary OCG-C. Even after these attempts if a connection can't be established, the client then should make use of Lookup Service to determine the connection points once again.

4. Session Management

4.1 Establishing a Binary Session

Each client will use the assigned IP address and port provided via the Lookup Service to establish a TCP/IP connection with the OCG-C. The client will initiate a Binary session at the start of each trading day by sending the Logon message.

A client must identify itself using the Comp ID field. The OCG-C will validate the Comp ID, password and IP address of the client.

Once the client is authenticated, the OCG-C will respond with a Logon message with Session Status set to Session Active (0). If the client's Logon message included the field New Password and the client is authenticated, the OCG-C will respond with a Logon message with Session Status set to Session Password Changed (1).

The client must wait for the Logon from the OCG-C before sending additional messages. If additional messages are received from the client before the exchange of Logon messages, the TCP/IP connection with the client will be disconnected.

If a logon attempt fails for the following reasons, the OCG-C will send a Logout or a Reject and then terminate the session; the Session Status of the Logout message will indicate the reason for the logout:

- Password failure
- Comp ID is locked
- Logon is not permitted during this time

For all other reasons, including the following, the OCG-C will terminate the session without sending a Logout or Reject:

- Invalid Comp ID or IP address

If during a logon of a client (i.e., a Comp ID), the OCG-C receives a second connection attempt while a valid binary session is already underway for that same Comp ID, the OCG-C will terminate both connections without sending a Logout or Reject message.

Inbound message sequence number will not be incremented if the connection is abruptly terminated due to the logon failure.

If a session level failure occurs due to a message sent by the client which contains a sequence number that is less than what is expected and the PossDup is not set to 1 (Yes), then the OCG-C will send a Logout message and terminate the Binary connection. In this scenario the inbound sequence number will not be incremented but the outbound sequence number will be incremented.

If the OCG-C does not respond to the session initiation (client initiated Logon message), the client is expected to wait for a time period of **60 seconds** prior to terminating the connection. The client is expected to retry session initiation after an elapsed time period of **60 seconds**.

If a client is disconnected abruptly or via a Logout message from the OCG-C, the client is expected to wait for a time period of **10 seconds** prior to reconnecting to the OCG-C.

4.2 Message Sequence Numbers

Under the binary protocol, the client and OCG-C will each maintain a separate and independent set of incoming and outgoing message sequence numbers. Sequence numbers

should be initialized¹ to 1 (one) at the start of the day and be incremented throughout the session. Either side of a binary session will track the:

- Next Expected Message Sequence number (starting at 1)
- Next To Be Sent Message Sequence number (starting at 1); with respect to the contra-party.

Monitoring sequence numbers will enable parties to identify and react to missed messages and to gracefully synchronize applications when reconnecting during a Binary session.

Any message sent by either side of a binary session will increment the sequence number unless explicitly specified for a given message type.

If any message sent by one side of a binary session contains a sequence number that is LESS than the Next Expected Message Sequence number then the other side of this session is expected to send a Logout message and terminate the Binary connection immediately, unless the PossDup flag is set to 1 (Yes)

A Binary session will not be continued to the next trading day. Both sides are expected to initialize (reset to 1) the sequence numbers at the start of each day. At the start of each trading day if the client starts with a sequence number greater than 1 then the OCG-C will terminate the session immediately without any further exchange of messages.

4.3 Heart Beat and Test Request

The client and the OCG-C will use the Heartbeat message to monitor the communication line during periods of inactivity and to verify that the interfaces at each end are available.

The heartbeat interval is expected to be set as **20 Seconds**.

The OCG-C will send a Heartbeat anytime it has not transmitted a message for the duration of the heartbeat interval. The client is expected to employ the same logic.

If the OCG-C detects inactivity for a period longer than **3 heartbeat intervals**, it will send a Test Request message to force a Heartbeat from the client. If a response to the Test Request is not received within a reasonable transmission time (recommended being an elapsed time equivalent to 3 heartbeat intervals), the OCG-C will send a Logout and break the TCP/IP connection with the client. The client is expected to employ similar logic if inactivity is detected on the part of the OCG-C.

4.4 Terminating a Binary Session

Session termination can be initiated by either the OCG-C or the client by sending a Logout message. Upon receiving the Logout request, the contra party will respond with a Logout message signifying a Logout reply. Upon receiving the Logout reply, the receiving party will terminate the connection.

If the contra-party does not reply with either a Resend Request or a Logout reply, the Logout initiator should wait for **60 seconds** prior to terminating the connection.

The client is expected to terminate each Binary connection at the end of each trading day before the OCG-C service is shut down. However, all open Binary connections will be terminated (a Logout message will be sent) by the OCG-C when its service is shut down. Under exceptional circumstances the OCG-C may initiate the termination of a connection during the trading day by sending the Logout message.

¹ Lookup service related messages (i.e., Lookup Request and Lookup Response) are expected to have a sequence number of 1 always; and these sequence numbers have no relationship with the sequence numbers for the session referred to here.

If, during the exchange of Logout messages, the client or the OCG-C detects a sequence gap, it should send a Resend Request.

4.5 Re-establishing a Binary Session

If a Binary connection is terminated during the trading day it may be re-established via an exchange of Logon messages.

Once the Binary session is re-established, the message sequence numbers will continue from the last message successfully transmitted prior to the termination.

4.6 Sequence Reset

The sequence reset could be done in two modes;

1. Gap-fill mode:

Gap-fill mode is expected to be used by one side when skipping session level messages which can be ignored by the other side.

2. Reset mode:

Reset mode is used only in exceptional scenarios to indicate a reset in the session's starting sequence number. This mode can ONLY be used by the OCG-C. Client initiated resets would be rejected by the OCG-C.

Following scenarios exist:

4.6.1 During a Session

The OCG-C and the client may use the Sequence Reset message in Gap Fill mode if either side wishes to increase the expected incoming sequence number of the other party.

The OCG-C may also use the Sequence Reset message in Sequence Reset mode if it wishes to increase the expected incoming sequence number of the other party. The Sequence Reset mode should only be used to recover from an emergency situation. It should not be relied upon as a regular practice.

4.6.2 When starting a new Session

4.6.2.1 Reset Initiated by the Client

Reset sequence (reset to 1) through the Logon Message will not be facilitated by the OCG-C. In order to reset the sequence (reset to 1), the client should manually inform the HKEX Operations Desk.

4.6.2.2 Reset Initiated by the OCG-C

The system has been designed with fault tolerance and disaster recovery technology that should ensure that the OCG-C retains its incoming and outgoing message sequence numbers for each client in the unlikely event of an outage. However, the client is required to support a manual request by HKEX to initialize sequence numbers prior to the next login attempt.

4.7 Fault Tolerance

After a failure on client side or on OCG-C side, the client is expected to be able to continue the same session.

In case of a catastrophic scenario, the binary gateway will restart from a higher sequence number considering the previous session or may start from sequence number 1.

If the sequence number is reset to 1 by the OCG-C, all previous messages will not be available for the client side.

The client and the OCG-C are expected to negotiate on the Next Expected Message Sequence number and Next To Be Received Sequence number through an alternate medium prior to initiating the new session (Manually setting the sequence number for both ends after having a direct communication with the client).

4.8 Checksum Validation

The OCG-C performs a checksum validation on all incoming messages into the input services. Incoming messages that fail the checksum validation will be rejected and the connection will be dropped by the OCG-C without sending a logout.

Conversely, the OCG-C stamps an identically calculated checksum field on all outgoing messages from the input interfaces. In case of a checksum validation failure, the client is expected to drop the connection and take any appropriate action before reconnecting. Messages that fail the checksum validation should not be processed.

This checksum is a **CRC32C** value with the polynomial **0x1EDC6F41**, presented as a 32-bit unsigned integer (http://en.wikipedia.org/wiki/Cyclic_redundancy_check#CRC-32C).

5. Recovery

5.1 General Message Recovery

- A gap is identified when an incoming message sequence number is found to be greater than Next Expected Message Sequence number.
- The Resend Request will indicate the Start Sequence and End Sequence of the message gap identified and when replying to a Resend Request, the messages are expected to be sent strictly honouring the sequence.
- If messages are received outside of the Start and End sequence numbers, then the recovering party is expected to queue those messages until the gap is recovered.

During the message recovery process, the recovering party will increment the Next Expected Sequence number accordingly based on the messages received. If messages applicable to the message gap are received out of sequence then the recovering party will drop these messages.

- The party requesting the Resend Request can specify “0” in the End Sequence to indicate that they expect the sender to send ALL messages starting from the Start Sequence.

In this scenario, if the recovering party receives messages with a sequence greater than the Start Sequence, out of sequence, the message will be ignored.

- Administrative messages such as Sequence Reset, Heartbeat and Test Request which can be considered irrelevant for a retransmission could be skipped using the Sequence Reset message in gap-fill mode.

Note that the OCG-C expects the client to skip Sequence Reset messages when replying to a Resend Request at all times.

- When resending messages, the OCG-C would use either PossDup or PossResend flag to indicate whether the messages were retransmitted earlier.

If PossDup flag is set, it indicates that the same message with the given sequence number with the same business content may have been transmitted earlier.

In the case where PossResend flag is set, it indicates that the same business content may have been transmitted previously but under the different message sequence number. In this case business contents needs to be processed to identify the resend. For example, in Execution Reports the Execution ID may be used for this purpose.

5.2 Resend Request

The client may use the Resend Request message to recover any lost messages. This message may be used in one of three modes:

- (i) To request a single message. The Start Sequence and End Sequence should be the same.
- (ii) To request a specific range of messages. The Start Sequence should be the first message of the range and the End Sequence should be the last of the range.
- (iii) To request all messages after a particular message. The Start Sequence should be the sequence number immediately after that of the last processed message and the End Sequence should be zero (0).

5.3 Logon Message Processing – Next Expected Message Sequence

Upon receipt of a Logon message from a client, the OCG-C will validate the Comp ID and the Password. If this validation results in an invalid Comp ID or invalid password the OCG-C would terminate the session with the client without any further exchange of messages.

If the Logon request is validated successfully for Comp ID and password, the OCG-C will move onto validate the Next Expected Message Sequence number of the incoming Logon message.

If the Next Expected Message Sequence number indicated is:

1. Greater than the OCG-C's Next To Be Sent Sequence number, then the session will be terminated immediately after sending the logout message (i.e., manual intervention is required in this case).
2. Equal to the OCG-C's Next To Be Sent Sequence number, then the OCG-C will start sending message starting from the indicated sequence number
3. Less than the OCG-C's Next To Be Sent Sequence number, then the OCG-C would consider this as a gap-fill (i.e., the client has not received these messages and the OCG-C has to resend them now²) and send messages starting from the indicated message up to the logon message sequence and skip the logon message sequence using a gap-fill and continue sending new messages from there on

If the Next Expected Message Sequence number indicated is valid then the OCG-C will send a Logon signifying a logon reply specifying the Next Expected Message Sequence number from the client. Immediately following the logon reply, the OCG-C would start message transmission as indicated above.

The client upon receipt of the Logon message from the OCG-C is expected follow the exact steps as indicated above.

Neither side should generate a Resend Request based on the Sequence Number of the incoming Logon message but should expect any gaps to be filled automatically by following the Next Expected Sequence processing described above².

Note that indicating the Next Expected Message Sequence number in the Logon request is mandatory.

5.4 Possible Duplicates

The OCG-C handles possible duplicates according to the Financial Information Exchange – FIX protocol.

5.5 Possible Resends

5.5.1 Client Initiated Messages

The OCG-C does not handle possible resends for the client-initiated messages (e.g., New Order, Quote, etc.) and the message will be processed without considering the value in the PossResend field. Any message with duplicate Client Order ID will be rejected based on the Client Order ID uniqueness check and messages which conform to the uniqueness check will be processed as normal messages.

² During the period where the OCG-C is resending messages to the client, the OCG-C does not allow another Resend Request from the client. If a new Resend Request is received during this time, the OCG-C will terminate the session immediately without sending the Logout message.

5.5.2 OCG-C Initiated Messages

The OCG-C may use the PossResend field to indicate that an application message may have already been sent under a different sequence number. The client should validate the contents (e.g., Execution ID) of such a message against those of messages already received during the current trading day to determine whether the new message should be ignored or processed.

5.6 Gap Fills

The following messages are expected to be skipped using gap-fills when being retransmitted:

1. Logon
2. Logout
3. Heartbeat
4. Test Request
5. Resend Request
6. Sequence Reset

All other messages are expected to be replayed within a retransmission.

5.7 Transmission of Missed Messages

The Execution Report, Order Mass Cancel Report, Quote Status Report, Trade Capture Reports/Acks, Business Message Reject and Reject messages generated during a period when a client is disconnected from the OCG-C will be sent to the client when it next reconnects. In the unlikely event the disconnection was due to an outage of the OCG-C, Business Message Reject and Reject messages may not be retransmitted, and the messages which will be retransmitted to the client will include a PossResend set to 1 (Yes).

6. Service Description

6.1 Data Types

The table below describes each data type included in all of the messages in the Binary Trading Gateway.

6.2 Message Composition

Each message comprises of the following logical components:

1. Header
2. Body
3. Trailer

Fields within a message are formed in the same order as the composition given above.

Fields present within the body of the message is defined through a field presence map where the present fields are indicated as part of the header.

Fields which are part of the header and the trailer are considered mandatory.

6.2.1 Field Presence Map

The binary protocol provides a concept of field presence maps per each message type where using these bitmap fields available within the message, senders could indicate the fields available within the message in a dynamic nature.

Each bit in the presence map will represent a field and the sequence in which the fields should be included into the message will be based on the bit position (starting from the most significant bit position). All fields applicable to a particular presence map should be included into message immediately following the applicable presence map.

For example, consider an 8 bit presence map. Positions 1, 2 and 3 indicate Instrument, Client Order ID and Order Quantity respectively where rest of the positions has not been assigned to a field.

To indicate the presence of the fields Instrument and Order Quantity the presence map will be set as shown below:

The applicable data types and lengths of the body fields are provided in the data dictionary. Based on the available fields as indicated by the field presence map, the recipient of the message is expected to decode the message accordingly.

Bit position for a field that commonly appears in multiple messages may be different; each message will have its own bit position for individual fields present in that message.

6.2.2 Repeating Blocks and Nested Repeating Blocks

The binary protocol supports repeating blocks within the message body while also allowing nested repeating blocks within a repeating block.

When indicating a repeating block the field presence map will only indicate the presence of the repeating block. Based on the repeating block construct, the receiving party is expected to evaluate the field contents and the numbers of repeating blocks.

This specification describes the repeating block construct and the relevant field information such as the data types required to identify the message contents and also to calculate header and trailer information such as message length and checksums.

Each repeating block construct will have a repeating block header field which is immediately followed by a field presence map which will indicate the presence of the applicable fields in that repeating block and any nested repeating blocks included within.

For example, consider an 8-bit field presence map included in the message header:

6.3 Security Identification

Instruments will be identified using the Security ID field. It is required to specify Security ID Source as Exchange Symbol (8) and Security Exchange as XHKG (similar to FIX exchange code for HKEX). Security ID with leading zeroes will not be accepted.

6.4 Party Identification

Party Identification is defined as follows:

- Any Broker ID with leading zeroes will be rejected
- BS User ID if specified would be restricted to numeric digits only with possible range of values being 1 to 99,999,999; a value with leading zeroes will be rejected.
- The BCAN Field should consist of a 6-alphanumeric CE number assigned by the SFC, a separator “.”, followed by a BCAN which is a randomly assigned number not exceeding 10 digits. For example, if the CE number of a Relevant Regulated Intermediary and the BCAN assigned to the client are ABC123 and 0000002568 respectively, then “ABC123.2568” should be set out in the BCAN Field when submitting the order to SEHK. It should be noted that the BCAN Field would not be echoed back in any of the Execution Report or Trade Capture Report messages.

CE Number Format:

- 6 alphanumeric CE number

Separator Format:

- A full stop character, i.e. “.”

BCAN Format:

- An integer of up to 10 digits that is randomly assigned number and ranges from 100 to 9,999,999,999. 0 to 99 are reserved.

- *Leading zero is not allowed.*
- *Specific reserved BCAN values (after the relevant CE no.):*
 - *1 - sell only client*
 - *2 - aggregated order or aggregated off-exchange trade*

6.5 Text Field

The Text Field sent in any business message from a client will be used as Broker Comment/Broker Reference field, and may not contain more than 10 characters; if the Text field contains more than this permitted number of characters, the additional characters will be truncated.

Additionally, this text field is expected to contain only printable characters excluding any punctuation mark.

6.6 Order Handling

6.6.1 Order Types

The client may submit the following order types:

6.6.3 Order, Quote, Trade and Execution Identifiers

6.6.3.1 Client Order ID

The client must ensure each Client Order ID to be unique per Submitting Broker ID as an identifier of the order. The client should comply with the Binary protocol and ensure uniqueness of Client Order IDs across all messages (e.g., New Order, Cancel Request, etc.) across trading days sent under a particular Submitting Broker ID. However during the initial launch (and until further notice) the uniqueness is required to be within a trading day and the contents of Client Order ID would be restricted to numeric digits only with possible range of values being 1 to 99,999,999. Client order IDs with leading zeroes will be rejected by OCG-C.

The client must, in terms of the Binary protocol, specify the Client Order ID when submitting a New Order, Cancel Request, Mass Cancel Request or an Amend Request.

6.6.3.2 Quote Bid ID, Quote Offer ID and Quote Message ID

The client must ensure Quote Bid ID, Quote Offer ID and Quote Message ID to be unique per Submitting Broker ID as an identifier of the quote. The client should comply with the Binary protocol and ensure uniqueness of these IDs across all messages sent under a particular Submitting Broker ID.

The client must, in terms of the Binary protocol, specify

- Quote Bid ID and Quote Offer ID when submitting a Quote
- Quote Message ID when submitting a Quote Cancel

Quote Bid ID, Quote Offer ID and Quote Message ID will be treated the same as Client Order ID for order related messages from the perspective of uniqueness, contents and restrictions.

6.6.3.3 Trade Report ID

The client must ensure each Trade Report ID to be unique per Submitting Broker ID as an identifier of the trade in the Trade Capture Reports sent by the client. The client should comply with the Binary protocol and ensure uniqueness of Trade Report IDs sent in the Trade Capture Reports under a particular Submitting Broker ID.

Trade Report ID is required to be unique within a trading day and the contents of this ID would be restricted to numeric digits only with possible range of values being 1 to 99,999,999. However, Trade Report ID need not be unique across all Client Order ID equivalent fields (such as Quote Bid ID, Quote Offer ID, Quote Message ID etc). Trade Report IDs with leading zeroes will be rejected by OCG-C.

6.6.3.4 Order ID

The OCG-C will use the Order ID field of the Execution Report to keep track of orders with the matching system.

In terms of the Binary protocol, unlike Client Order ID which requires a chaining through amend requests and cancel requests, the Order ID of an order will remain constant throughout its life. However upon an amend request which results in a successful cancel/replace order in the market, the replaced order will be assigned a new Order ID.

The client has the option to either specify the Order ID when submitting a Cancel Request or an Amend Request or not. However, in the event where the client is submitting a Cancel Request on behalf of another OCG-C session, the Order ID must be specified in the Cancel Request message.

6.6.3.5 Trade ID

The OCG-C will use the Trade ID field of the Trade Capture Report to identify a trade in the event that the client requests to cancel/reject reported off-exchange trade (subject to applicable rules).

6.6.3.6 Execution ID

The OCG-C will use the Execution ID field to affix a unique identifier for each Execution Report. Execution IDs will be unique per trading day.

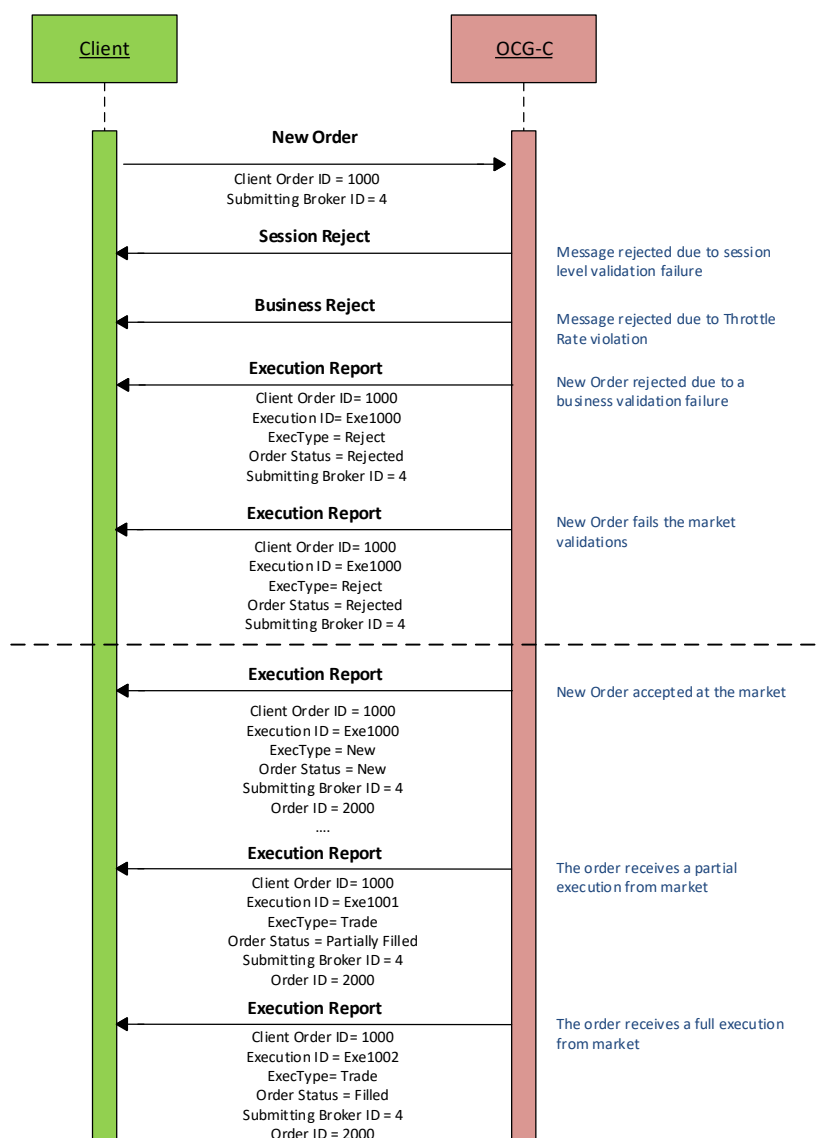
6.6.4 Order Submission

Single sided orders can be submitted into the OCG-C using the New Order and the updates to the order submitted will be published in the form of Execution Reports, Session Rejects or Business Message Rejects based messages.

The client must specify the Client Order ID when submitting a New Order Message.

For a Limit order, the Order Price must be specified whereas for a Market order Price must not be present; any order submission that does not adhere to this will be rejected.

6.6.5 Cancellations

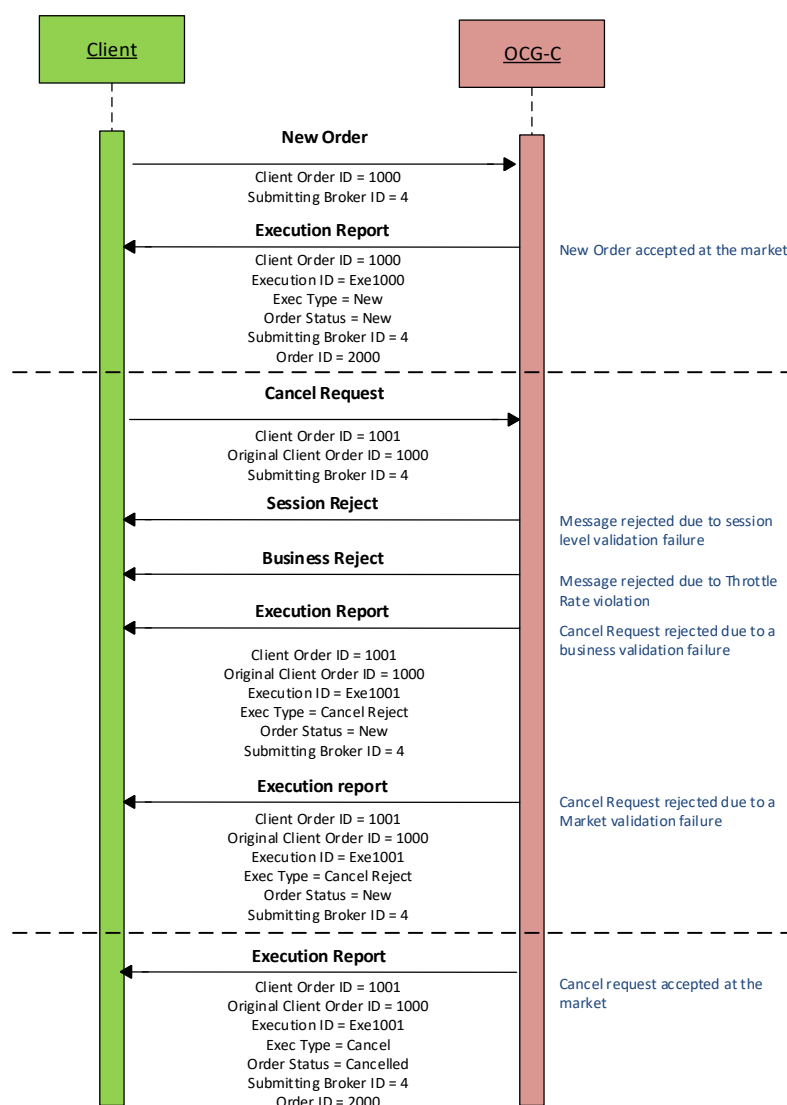
The remainder of a live order may be cancelled via the Cancel Request message. The OCG-C will respond with an Execution Report to confirm or reject the cancellation request.

The client should identify the order being cancelled by its Original Client Order ID. The client can specify the Order ID in the Cancel Request message but it is not a mandatory

requirement. If the Order ID is specified in the Cancel Request message, the system will validate the specified Order ID with the actual Order ID assigned to the particular order by the system (order is identified by the Original Client Order ID). The Cancel Request will be rejected if the specified Order ID is invalid based on this validation.

The client may not cancel an order that is fully filled/cancelled/expired. If the client sends a cancel request for an order for which an amendment or a cancellation is already being processed the incoming cancel request will be rejected.

6.6.6 Mass Cancellation

A client may mass cancel live orders via the Mass Cancel Request message. The OCG-C will respond with an Order Mass Cancel Report to confirm or reject the mass cancellation request.

If the Mass Cancel Request is accepted, the OCG-C will respond with an Order Mass Cancel Report where the Mass Cancel Response field will reflect the action taken by the OCG-C as a result of the Mass Cancel Request. The OCG-C will generate an Execution Report for each order that is cancelled due to the Mass Cancel Request.

If the Mass Cancel Request is rejected, the OCG-C will respond with an Order Mass Cancel Report with Mass Cancel Response = 0 (Cancel Request Rejected). The Mass Cancel Reject Code will indicate the reason why the Mass Cancel Request was rejected.

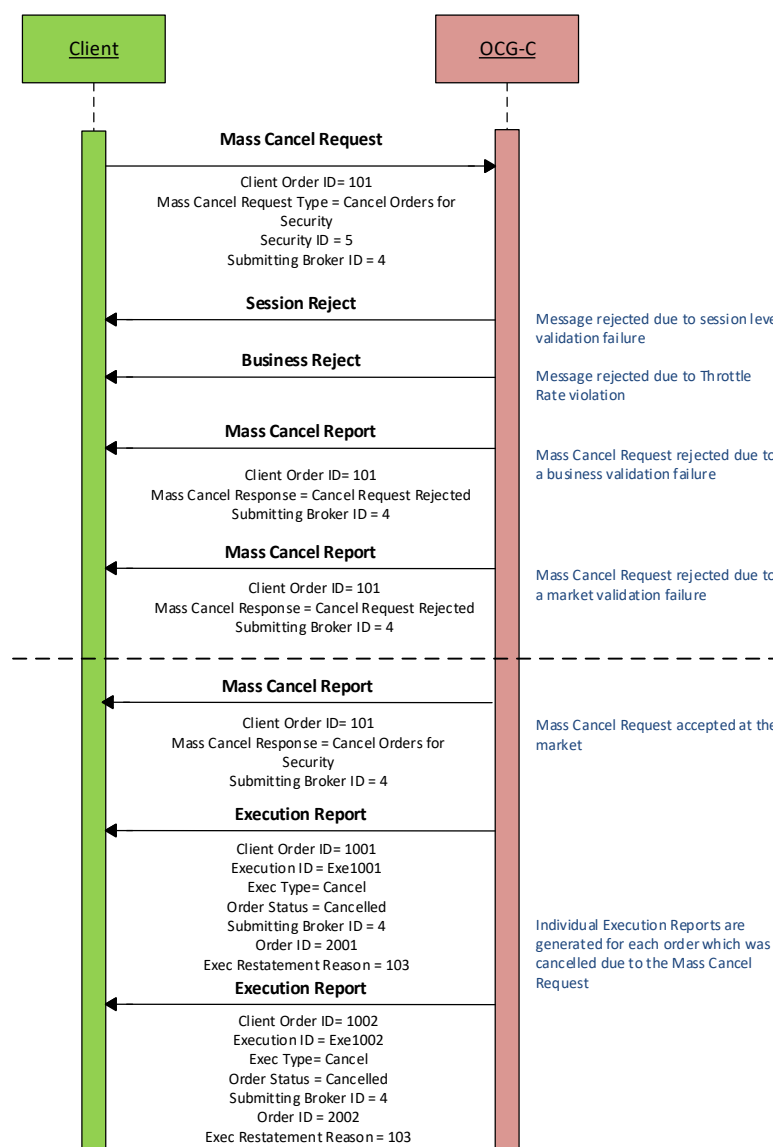
The client may use the Mass Cancel Request to mass cancel all orders, mass cancel orders for a particular instrument or a market segment by specifying the applicable mass cancel type in the Mass Cancel Request Type field. All orders to be mass cancelled here must belong to the given Broker ID associated with this client.

Though a Mass Cancellation request is accepted by the OCG-C, an individual order cancellation depends on the prevailing trading state of the instrument(s) when the mass cancellation request is received by the trading system. This is also applicable to OBO Mass Cancellation request.

The Binary fields relevant to each of the supported mass cancel types are outlined below:

6.6.6.1 Message Flow – Mass Cancel Request



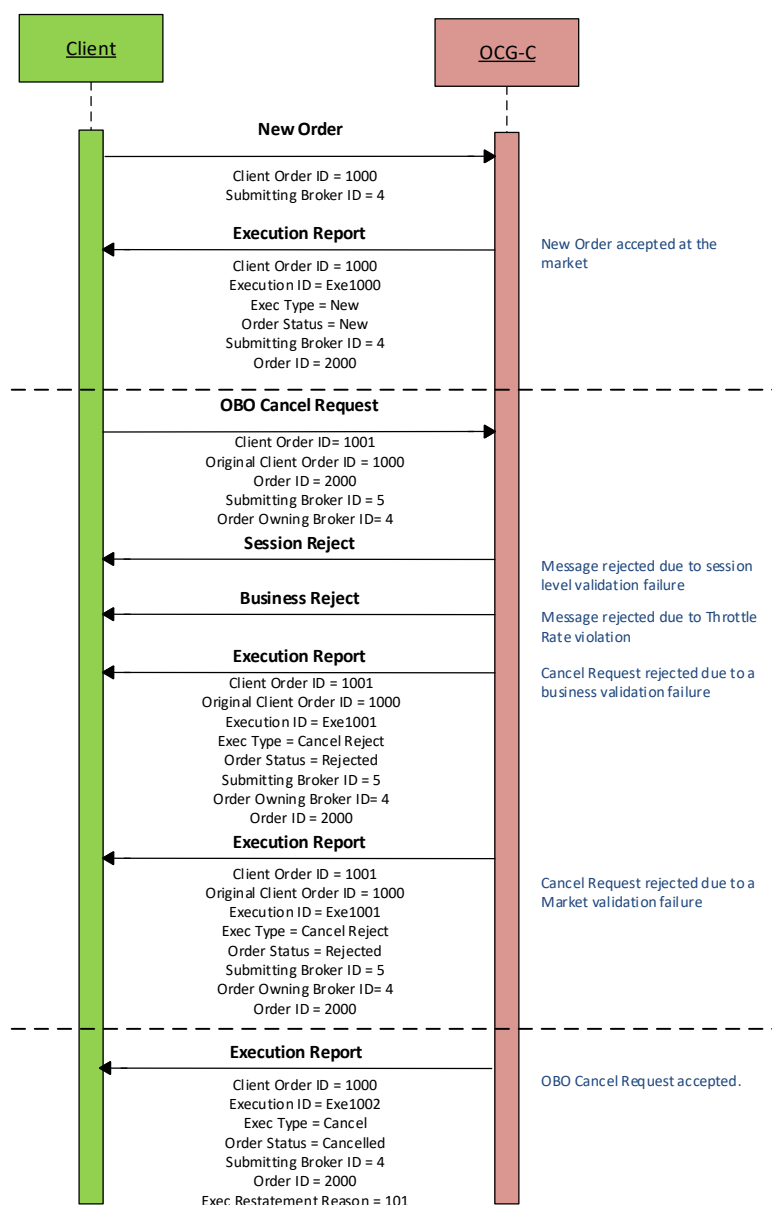
6.6.7 On Behalf Of (OBO) Cancellations

OBO Cancel functionality allows a Broker ID to cancel order(s) belonging to another Broker ID within the same member firm (Exchange Participant) but these two Broker IDs must belong to two different sessions, where either of these sessions is through OCG-C and the other may or may not be through OCG-C.

6.6.7.1 OBO Cancel Order

The client can perform an OBO Cancel for a single order by specifying the Order ID as well as the Order Owning Broker ID of that order in the Cancel Request message. In case the request is rejected the OCG-C will respond with an Execution Report to the submitter of the Cancel request. In the case of successful order cancellation, the Execution Report will be sent to the owner of the order as opposed to the submitter of the Cancel Request and no message will be sent to the submitter of the OBO cancel order request.

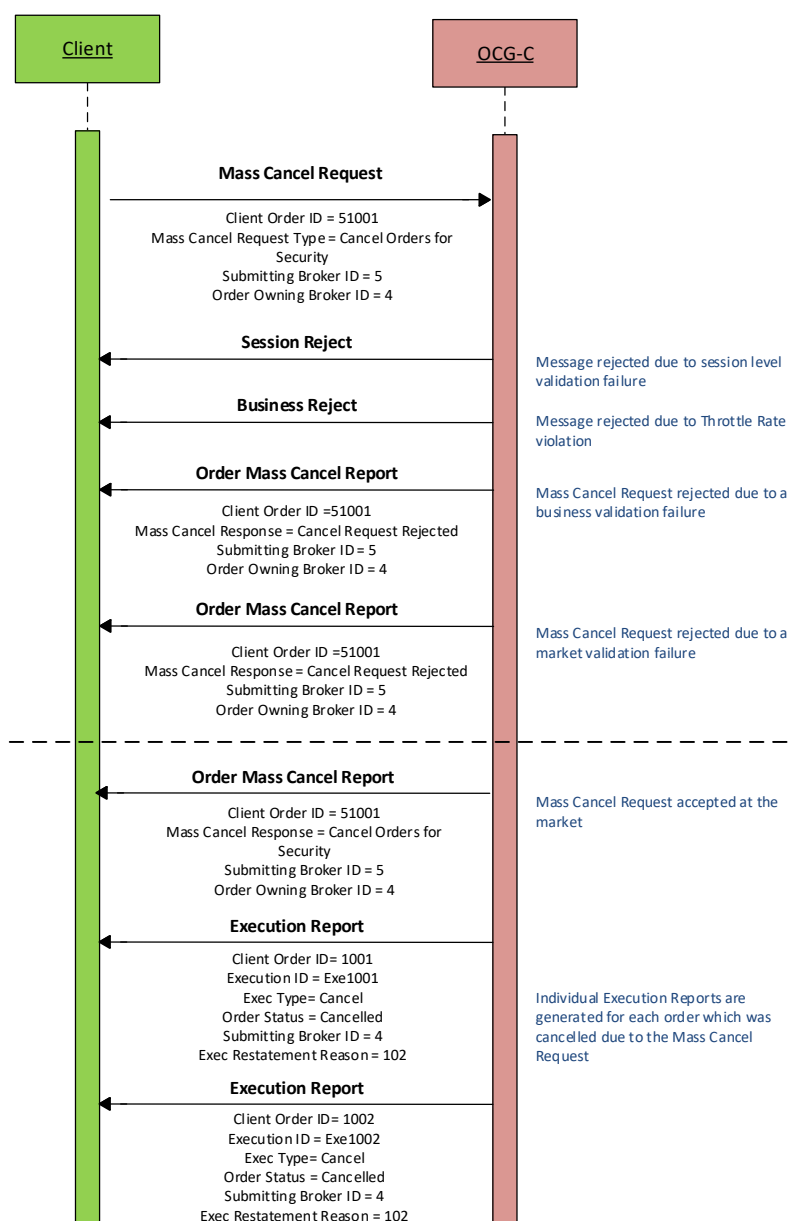
6.6.7.2 Message Flow – OBO Cancel Request



6.6.7.3 OBO Mass Order Cancellation

The client can perform an OBO Mass Cancel for a selected set of orders based on the Mass Cancel Request Type field in the Order Mass Cancel Request message. The OCG-C will respond with an Order Mass Cancel Report to accept or reject the mass cancellation request. These responses will be sent to the submitter of the Mass Cancel Request. In the case of successful order cancellations, Execution Reports will be generated for each order which was cancelled and which will be sent to the respective owner of the each order. It should be noted that OBO Mass Cancel is developed to safeguard EPs' interests in case of emergency. For this reason this function should be used only in emergency situations such as malfunctioning of the original OCG-C session, but not on a day-to-day basis to cancel orders on behalf of other working OCG-C sessions.

6.6.8 Amending an Order

The following attributes of a live order may be amended via the Amend Request message:

- Order Quantity
- Price
- Side (the only amendment allowed is to change from Sell to Sell Short and vice versa)
- Order Capacity
- Short Sell Indication (using Order Restrictions / Position Effect)
- Disclosure Instruction
- Text
- Broker Location ID

The OCG-C will respond with an Execution Report to confirm or reject the Amend Request sent by the client.

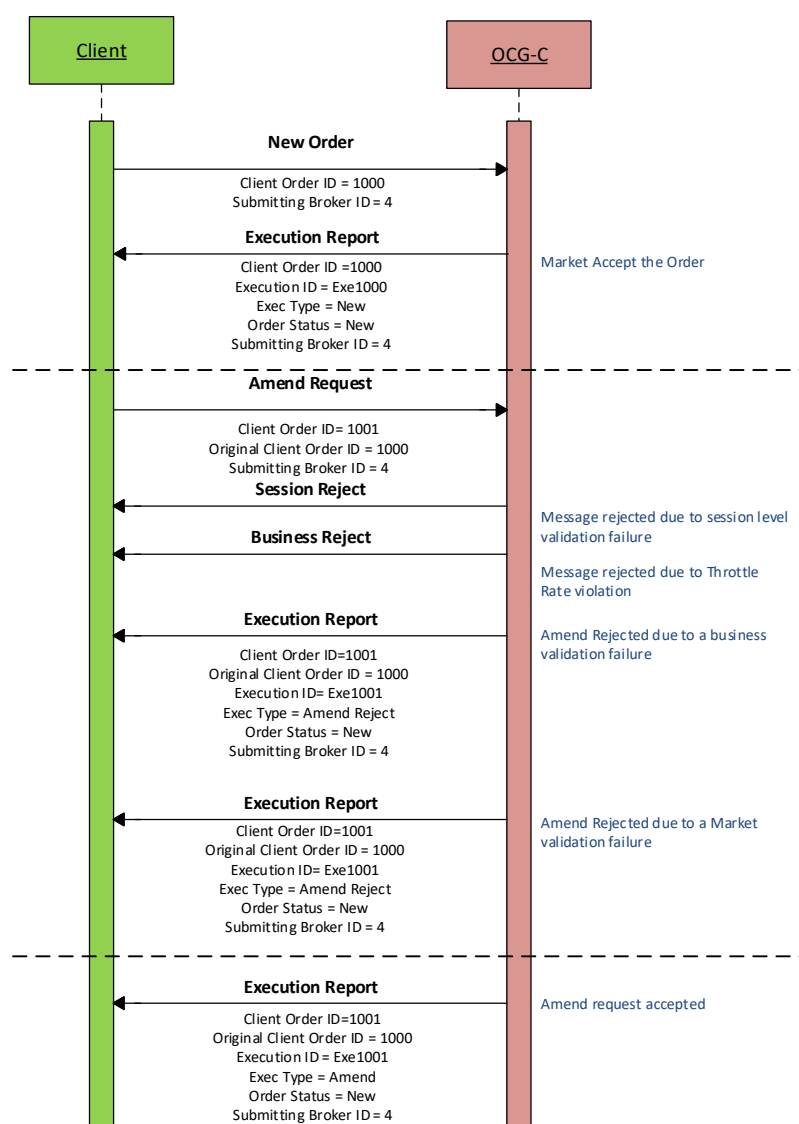
The client should identify the order being amended by its Original Client Order ID. The client may or may not specify the Order ID in the Amend Request message. If the Order ID is specified in the Amend Request message, it must be the Order ID assigned to this particular order as identified using the Original Client Order ID. The Amend Request will be rejected if the specified Order ID is invalid based on this validation.

The client may not amend an order that is fully filled or cancelled or expired.

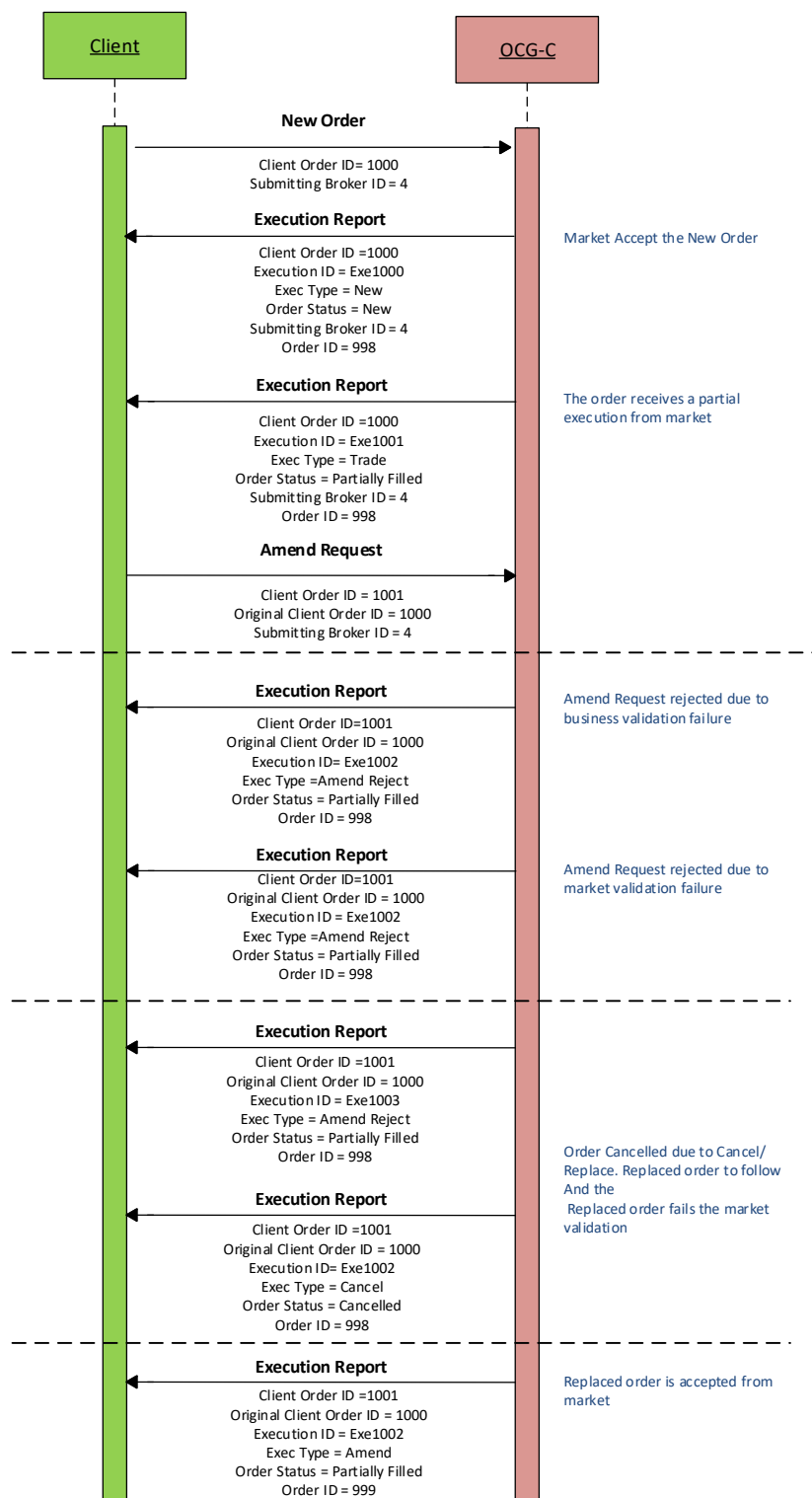
If the client sends an amend request for an order for which an amendment or a cancellation is already being processed the incoming amend request will be rejected.

The OCG-C will facilitate order chaining up to the maximum limit of 99,999,999 and will reject subsequent requests to amend if the Order Quantity of the amend request exceeds this value.

6.6.9 Cancel Auto-matched Trades

A trade already concluded for an order could be cancelled by the HKEX Market Operations. A trade cancel will be communicated to the client(s) via an Execution Report. The Execution

Report will include the Reference Execution ID in order to identify the particular trade which is being cancelled.

If a trade is cancelled in this manner, system will not reinstate the Leaves Quantity of that order by the busted (cancelled) quantity. In this specific scenario Order Quantity will NOT be equal to the summation of the Leaves Quantity and the Cumulative Executed Quantity.

6.6.10 Execution Reports

The Execution Report message is used to communicate many different events to the client. The events are differentiated by the value in the Exec Type field as outlined below:

6.7 Quote Handling

Quotes are input or modified as a two-sided (i.e. bid and offer) order pair. If one side of a quote fails the basic validations (e.g., price is not on tick, quantity is not on lot size, etc.), then both sides will be rejected. However, if a quote is accepted it is treated as two separate and independent limit orders where each of these two orders may be accepted or rejected (due to business validation failures).

Quotes may be submitted individually via the Quote message.

6.7.1 Acknowledgement

The OCG-C will respond with Execution Report(s) to confirm the Quote message. If the Quote message is rejected the OCG-C will respond with a Quote Status Report message.

The OCG-C will explicitly reject each Quote message via the Quote Status Report message with Quote Status field set to Rejected (5); the Quote Reject Code will indicate the reason why the quote is rejected.

6.7.2 Execution

The Execution Report message is used to notify the client if a quote is executed. The Client Order ID of the Execution Report will contain either the Quote Bid ID or the Quote Offer ID of the last Quote message based on the executed side of the Quote (bid or offer).

6.7.3 Updating a Quote

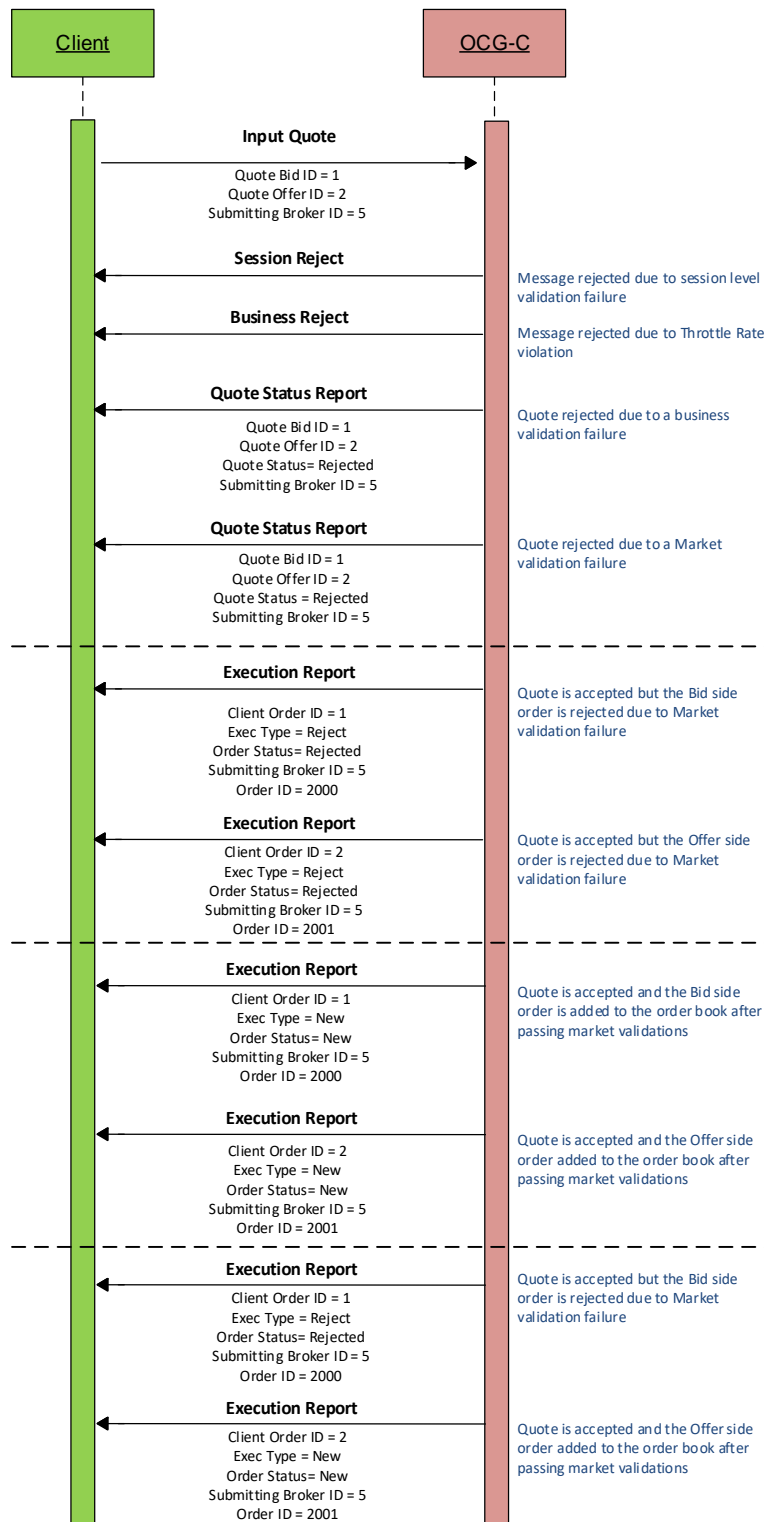
The client may update a live quote entry by sending another quote, via the Quote message, for the same instrument. When submitting an update, the client may:

- (i) Update both sides of a quote
- (ii) Update one side of a quote and leave the other side unchanged

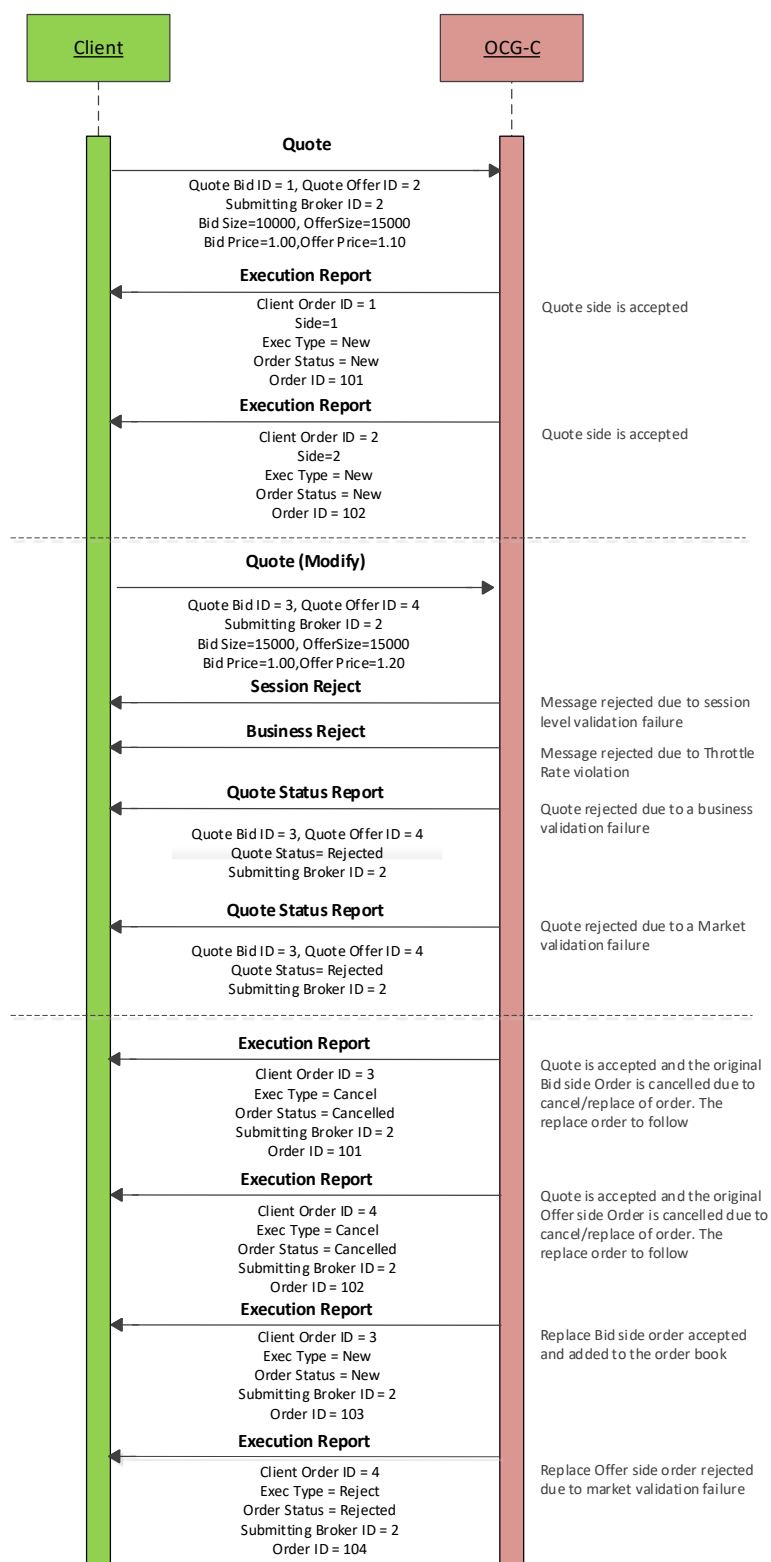
The client may update a side of a quote by providing a new price and/or quantity.

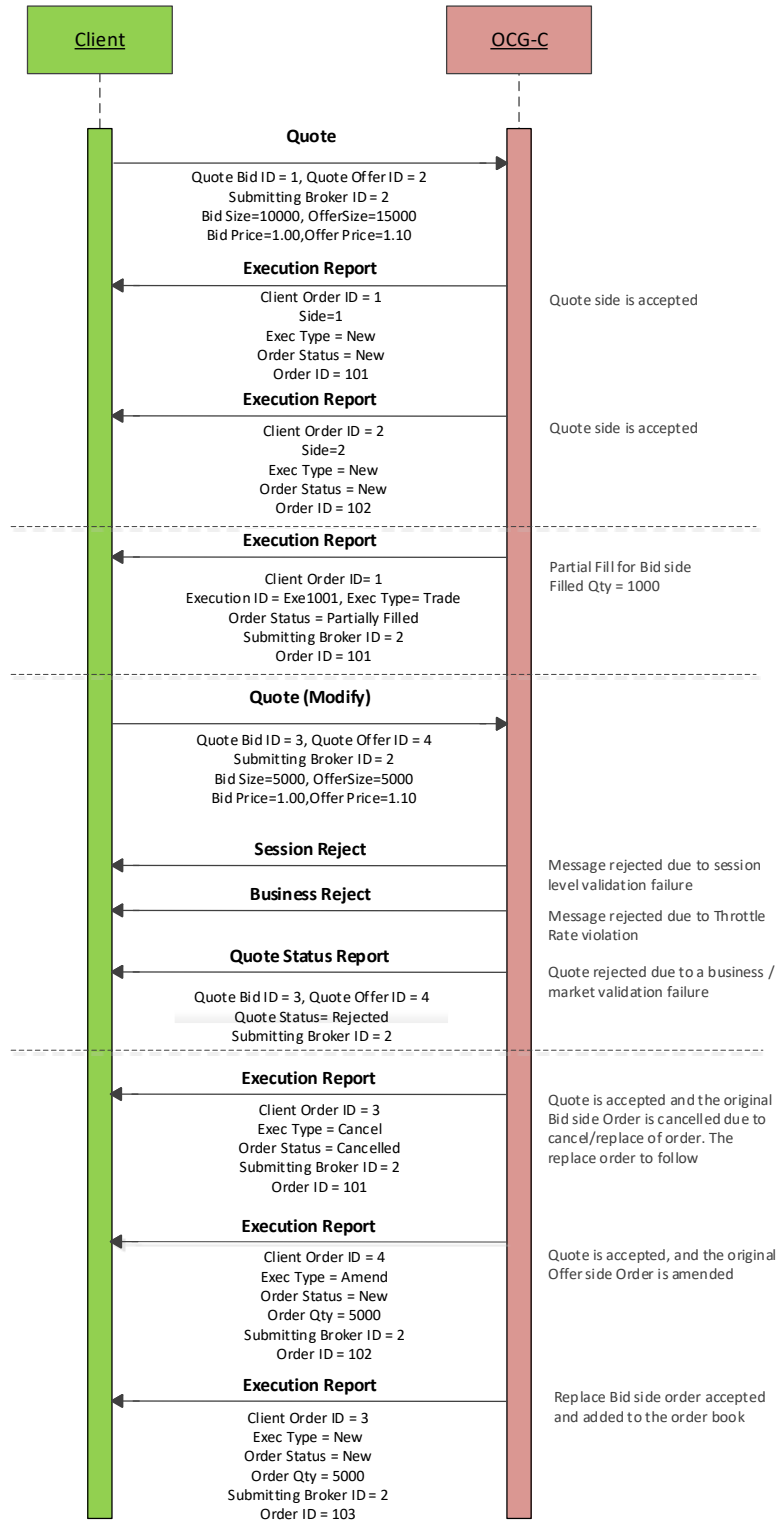

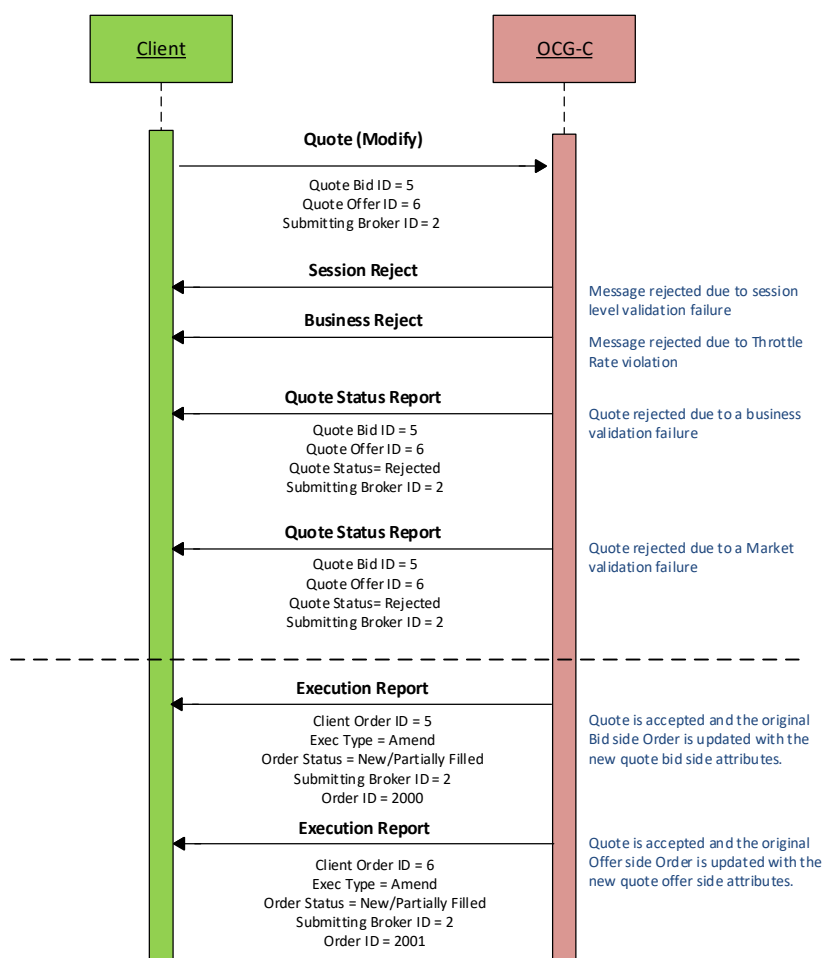


The client submits a quote to modify an existing quote in the market which results in order cancel/replace at the market:





The client submits a quote to modify an existing quote in the market which results in order updates at the market:

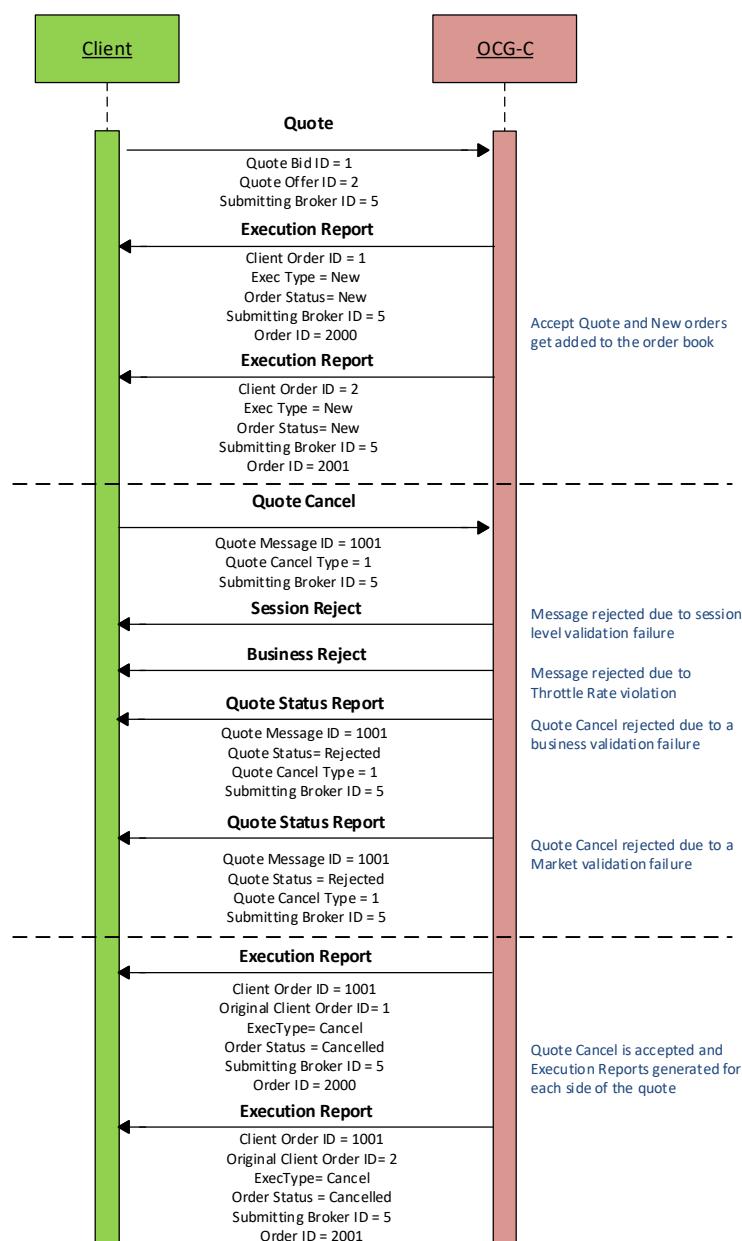


6.7.5 Cancelling a Quote

The client may use the Quote Cancel message to cancel a single quote entry. The message should include a Quote Cancel Type of Cancel for Instruments (1). The OCG-C will respond with Execution Report(s) for successful cancellation.

If the Quote Cancel message is rejected the OCG-C will respond with a Quote Status Report message. The Quote Status field will be set to Rejected (5) and the reason will be specified in the Quote Reject Code field.

6.8 Trade Report Handling

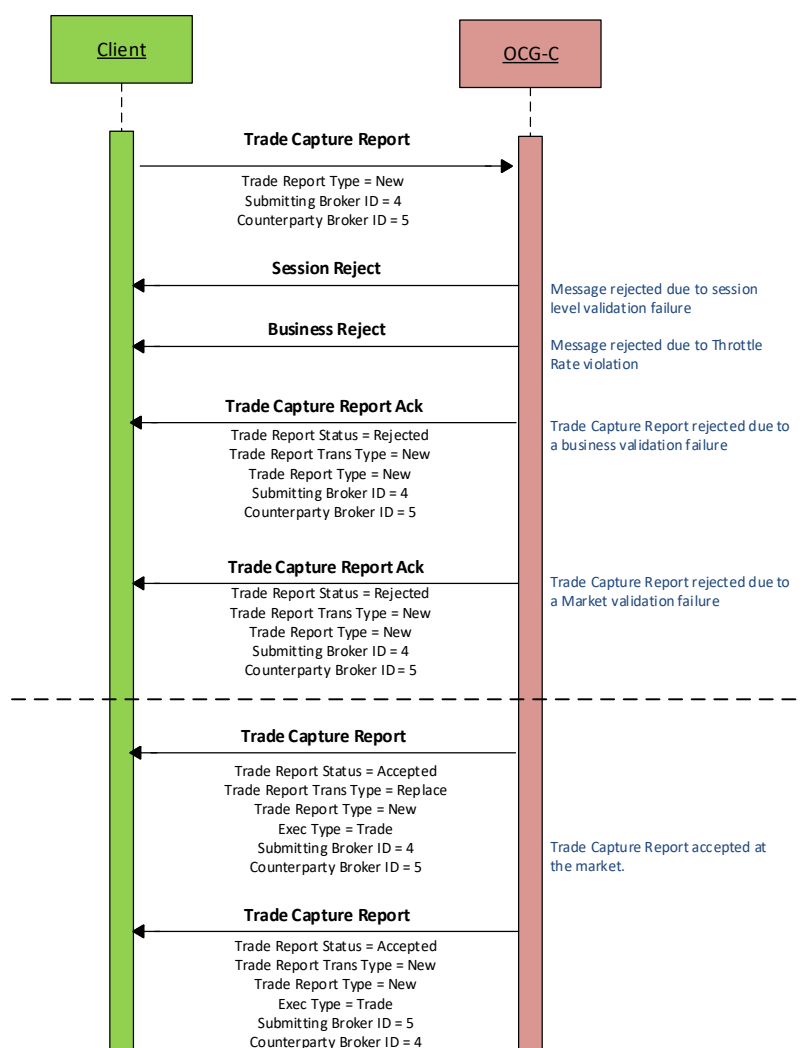
The client may use the Trade Capture Report message to report an off exchange trade or to cancel an alleged off exchange trade. In order to report an off exchange trade, the Trade Report Type field must be set to New (0) and in the case of cancelling a trade, this field must be set to Trade Report Cancel (6).

6.8.1 Trade Acknowledgement

Once a Trade is accepted, two Trade Capture Reports will be sent (if the trade has two sides) independently to the two broker IDs (buyer and seller broker IDs) involved in the trade with Exec Type set to Trade (F). The Trade Report Trans Type field of the Trade Capture Report will be set as Replace(2) for the reporting side and as New(0) for the counterparty side of the trade.

The OCG-C will explicitly reject Trade message via the Trade Capture Report Ack message to the submitter of the Trade Capture Report message. The Trade Report Status field will indicate whether the trade is Rejected (1) or not. If a trade is rejected, the reason will be specified in the Trade Report Reject Code field.

6.8.2 Trade Cancel

Purchasing side of an off-exchange trade may cancel the reported trade by submitting a Trade Capture report message with Trade Report Type field set to Trade Report Cancel (6).

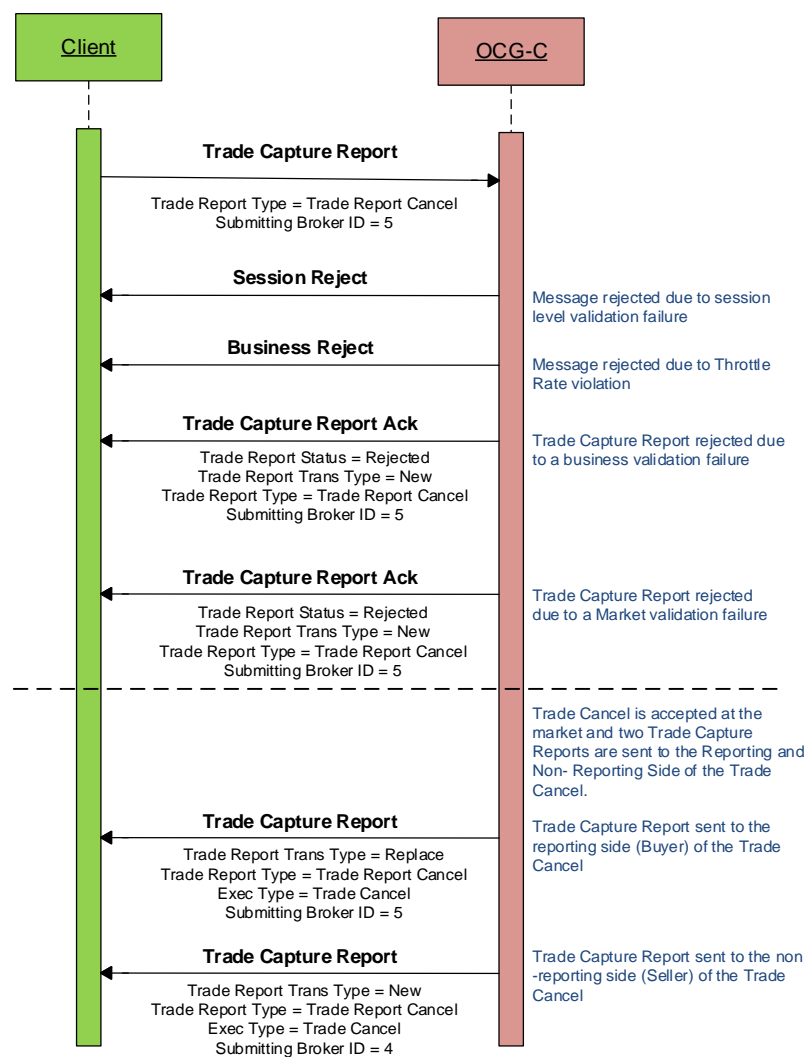
6.8.3 Trade Cancel Acknowledgement

Once a Trade Cancel is accepted, two Trade Capture Reports will be sent (if the trade has two sides) independently to the two broker IDs (buyer and seller broker IDs) involved in the trade with Exec Type set to Trade Cancel (H). The Trade Report Trans Type field of the Trade Capture Report will be set as Replace (2) for the side that submits this cancel request and as New (0) for the counterparty side of the trade.

The OCG-C will explicitly reject a Trade Cancel message via the Trade Capture Report Ack message to the submitter of the cancel request. The Trade Report Status field will indicate whether the trade is Rejected (1) or not. If a trade cancel request is rejected, the reason will be specified in the Trade Report Reject Code field.

6.8.4 BCAN Field Submission by Purchasing Side

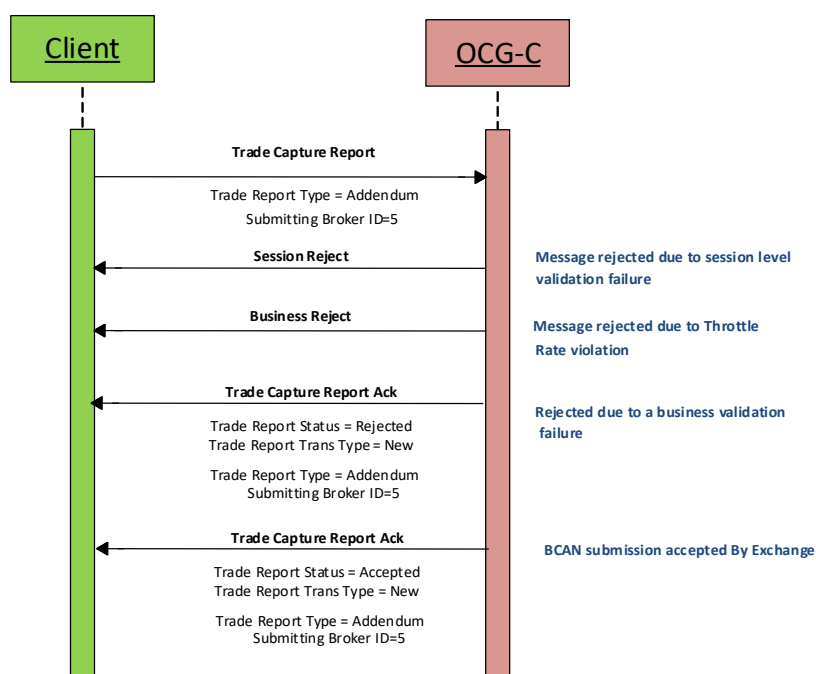
If the alleged trade is correct, purchasing side of the alleged off exchange trade needs to submit the BCAN Field of purchase side to Exchange via Trade Capture Report message where the Trade Report Type field must be set to 4 = Addendum. BCAN Field submission is mandatory for alleged trade quantity greater than or equal to one board lot and is optional for alleged trade quantity less than one board lot.

6.8.5 BCAN Field Submission Acknowledgement

After submitting the BCAN Field to Exchange, purchasing side will receive Trade Capture Report Ack from OCG-C with Trade Report Status field setting to 0 = Accepted if the BCAN Field submission is accepted, otherwise the Trade Report Status field is set to 1 = Rejected with reason specified in the Trade Report Reject Code field.

6.9 Odd Lot/Special Lot Order Handling

The OCG-C supports Odd lot/Special Lot order related functions in semi-automatic trading. The functions here include:

- submission of new order,
- cancellation of existing order and
- reporting a trade against a specific resting order

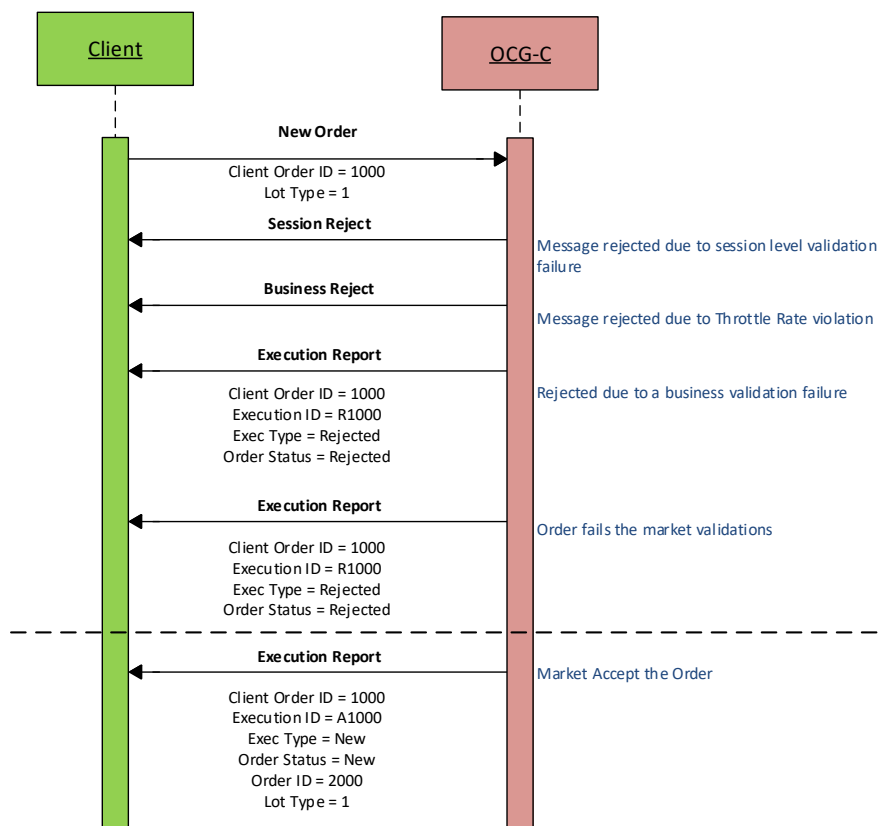

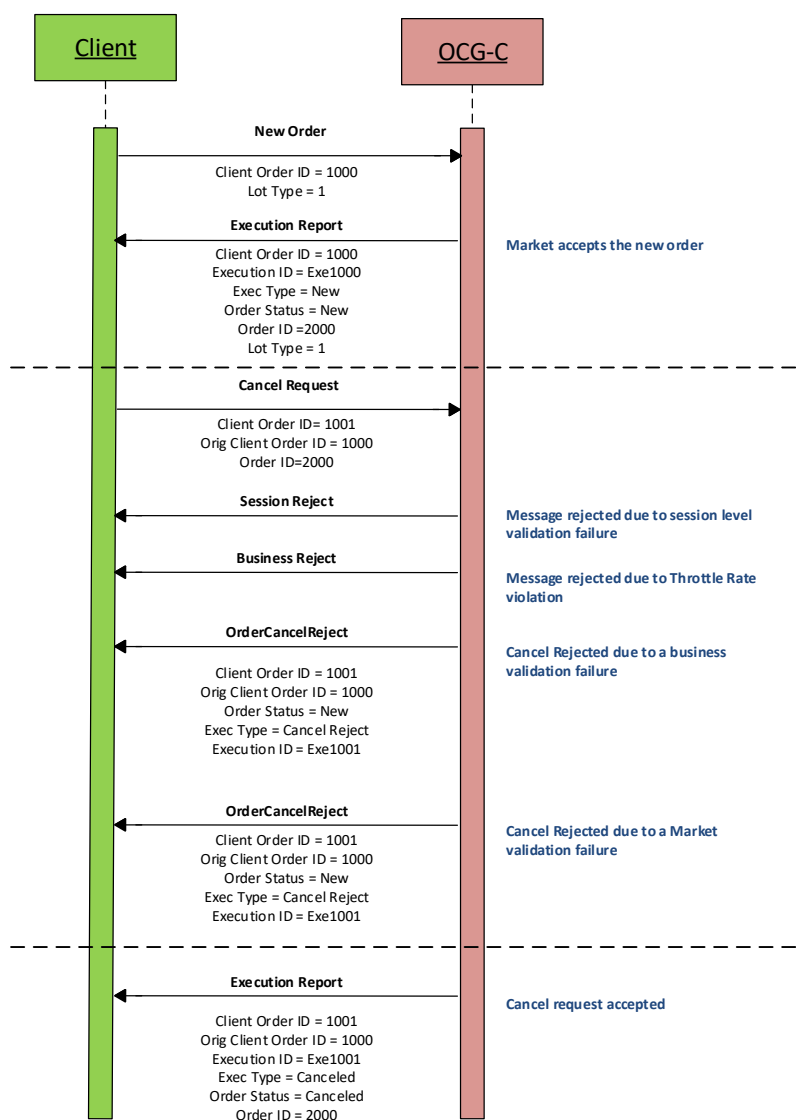
6.9.2 Order Cancellation

As for an odd lot/special lot order, a resting odd lot/special lot order may be cancelled via the Cancel Request message. The OCG-C will respond with an Execution Report to confirm or reject.

The client should identify the order being cancelled by its OrigClOrdID. The client can specify the OrderID in the Cancel Request message but it is not a mandatory requirement. If the OrderID is specified in the Cancel Request message, the system will validate the specified OrderID with the actual OrderID assigned to the particular order by the system (order is identified by the OrigClOrdID). The Cancel Request will be rejected if the specified OrderID is invalid based on this validation.

The client may not cancel an odd lot/special lot order that is fully filled/cancelled/expired. If the client sends a cancel request for an order for which a cancellation is already being processed the incoming cancel request will be rejected.

6.9.3 Order Amendment

An odd lot/special lot order may not be amended. Any amendment request for an odd lot/special lot order will be rejected by the OCG-C.

6.9.4 Trade Request

A semi-automatic odd lot/special lot trade request, pointing to a resting order (i.e., existing open order) may be submitted using Trade Capture Report message.

Since Trade Capture Report message can also be used to report an off-exchange trade, the OCG-C will identify the incoming Trade Capture Report being a semi-automatic odd lot/special lot trade if:

- Trade Type = 102 – Odd Lot Trade, and
- Existence of Order ID in the details of the Side opposite to the submitting side.

If the above criterion is not met then the OCG-C will treat the incoming Trade Capture Report as an off-exchange trade to be reported as described in [Section 6.8](#).

If the trade is accepted by the market then:

- Trade Capture Report submitter will receive a Trade Capture Report confirming the acceptance, and
- The resting order owner will receive a trade through Execution Report to confirm the trade.

Note that this resting order should be considered as fully filled.

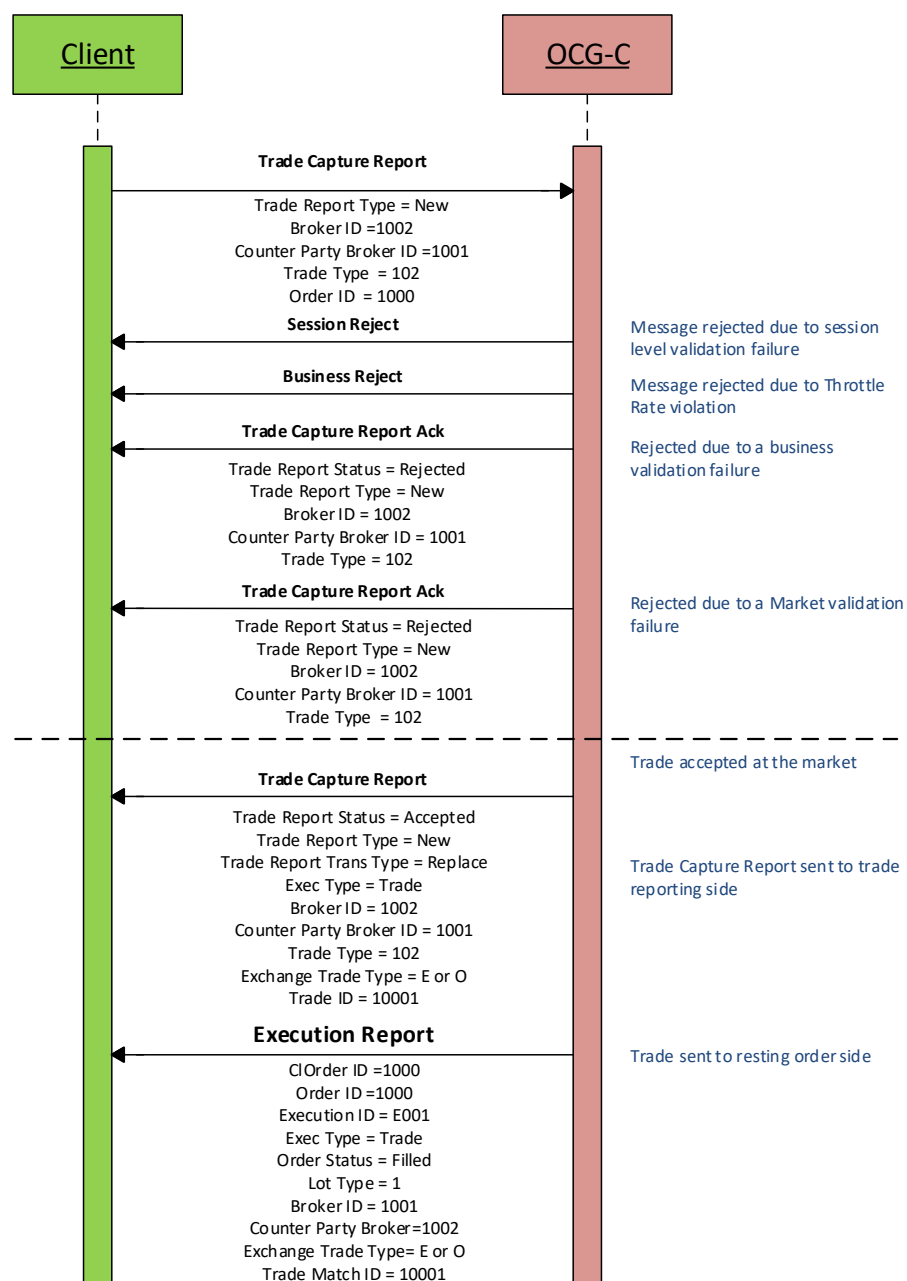
Whether the confirmed trade is odd lot or special lot may be determined by Exchange Trade Type as follows:

- E = Special Lot
- O = Odd Lot

If the trade is not accepted then the Trade Capture Report submitter will receive a Trade Capture Report Ack carrying the reason for rejection.

Once the trade is accepted, it can only be cancelled by the exchange subsequently.

6.10 Message Rejection

6.10.1 Session Level Reject

If an incoming message violates any message level validations such as data type mismatches or message structure mismatches, the messages are expected to be rejected back to the sender using a Reject message (applicable to both the client and the OCG-C).

6.10.2 Business Message Reject

Business Message Rejects will be used in rejecting business messages due to application level validation failures such as MPS rate violations, conditionally required field violations, etc.

6.11 Cancel On Disconnect

At the request of the member firm, all live orders (board lot and odd lot/special lot) and quotes submitted under a Comp ID can be configured to be automatically cancelled whenever the OCG-C identifies an abrupt disconnection of the client session in the following scenarios:

- OCG-C detects a network-level disconnection from the client without a Logout message prior to this disconnection,
- OCG-C detects that the client session is inactive with no heartbeats being received for the specified interval of time as described in [Section 4.3](#).

The OCG-C supports a delayed cancellation of orders once the OCG-C triggers the Cancel on Disconnect scenario. In this case, the actual cancellation is initiated upon the abrupt disconnection plus the delay duration as specified for the client session; if within this delay duration the client is able to re-establish the session, then cancellation will be not triggered. Also, the Cancel on Disconnect will not be triggered due to an internal HKEX OCG-C system outage or failure.

This feature does not guarantee that all live orders will be successfully cancelled as executions that occur very near to the time of disconnect may not be reported to the client. It also depends on the market/instrument trading state when the cancellation is received by HKEX securities trading system.

If the OCG-C activates the Cancel on Disconnect feature for the client, on a subsequent successful login this client will receive the execution report messages for the cancelled orders, if any.

This optional feature is provided as an alternative to the cancellation submission on behalf of the EP's manual process at present.

The configuration of the Cancel on Disconnect feature cannot be altered intra-day.

6.12 Message Rate Throttling

HKEX has implemented a scheme for throttling message traffic where each Comp ID is only permitted to submit up to a specified number of business messages per second (MPS).

The client can request for message rate entitlement information pertaining to that client by sending a Throttle Entitlement Request (25) message and the OCG-C will reply with a Throttle Entitlement Response (26) message to convey the message rate entitlement information.

Every message that exceeds the maximum rate of a Comp ID will be rejected via a Business Message Reject. In this situation, the remaining time for the present throttling interval will be indicated in the Reason text of the Business Message Reject.

HKEX reserves the right to drop the client session with or without sending a Logout (6) message to the client, if that client is found to be excessively violating the message rate.

6.13 Party Entitlements

The client can request for entitlement information for Broker IDs of that client via Party Entitlement Request Message. If the Request is accepted, Party Entitlement Report message will carry the entitlement information.

7.8 Business Messages – Trade Handling

7.8.1 Trade Capture – Submission

This set of messages used for reporting an off-exchange trade follows “Privately Negotiated Trade, Two-Party Report” as described by FIX protocol (reference: FIX 5.0 SP2 Volume 5).

According to the business processing flow:

- For all types of off-exchange trades except “Overseas”, the selling counterparty has the responsibility to report the resultant trade. Purchasing counterparties are able to review the trades reported by sellers, and can reject any alleged trades if they are believed to be incorrect. If the alleged trade is correct, purchasing side needs to submit the BCAN Field of purchase side to Exchange via Trade Capture Report message.
- Purchases can be input for off-exchange trades of type “Overseas” (i.e., one party to the trade is not a member of HKEX). Overseas trades are not reported with a correspondent/counterparty Broker ID and they cannot therefore be rejected.

The same set of messages is also used for reporting an odd lot/special lot trade in semi-automatic trading. Such a trade can be requested by either buyer or seller by pointing to a resting order.

Appendices

A. Password Policy

- Length is 8 characters.
- Must comprise of a mix of alphabets (A-Z and a-z) and digits (0-9)
- Must be changed on first-time logon or first logon after reset from HKEX market operations.
- New password can't be one of the previous 5 passwords.
- Can't be changed more than once per day.
- Session will be locked after 3 consecutive invalid passwords
- Expires every 90 days.
