Listing Rules Amendments relating to new headline categories

We have published today amendments to the Listing Rules to introduce new headline categories for announcements currently classified under "Corporate Positions and Committees/Corporate Changes" and "Miscellaneous" to facilitate investors' access to information published on the HKExnews website.

Currently issuers select the headlines (i) "Overseas Regulatory Announcement" when they publish on the HKExnews website regulatory information released to other stock exchanges under Main Board Listing Rules 13.10B/GEM Listing Rules 17.12, and (ii) "Other" for announcements where there are no applicable headlines.

The headlines "Overseas Regulatory Announcement" and "Other" currently capture a large number of announcements. To better classify announcements under these two headlines and facilitate investors' access, we introduce new headline categories as follows:

- Other Business Update
- Other Corporate Governance Related Matters
- Other Litigation
- Other Miscellaneous
- Other Trading Update
- Overseas Regulatory Announcement Board/Supervisory Board Resolutions
- Overseas Regulatory Announcement Business Update
- Overseas Regulatory Announcement Corporate Governance Related Matters
- Overseas Regulatory Announcement Issue of Securities and Related Matters
- Overseas Regulatory Announcement Other
- Overseas Regulatory Announcement Trading Update

These new headline categories replace the existing headlines "Overseas Regulatory Announcement" and "Other".
