Introducing the enhanced e-Submission System

Listed issuers are requested to note that the Exchange undertook enhancements work to improve the e-Submission System (the "ESS") in relation to the submission and dissemination of listed issuers' information. The enhancements include technology upgrade, system security and submission process improvements.

The enhanced ESS will be rolled out tentatively in early Q3 this year following a 5-month user migration. To facilitate listed issuers planning and preparation, please find below the major tasks and the tentative schedule:

Tentative Schedule	Planned Tasks	Description/Impact on Listed Issuers
11, 18 & 25 May 2019	User Familiarisation Sessions	A total of six user familiarisation sessions will be held on three Saturdays in May and each company will be assigned to a specific timeslot (see Appendix for details).
		Impact on listed issuers: All ESS users (including listed issuers and their authorized agents) may participate, on a voluntary basis, in the user familiarisation sessions to ensure that they have the opportunity to practice the enhanced ESS functions including a simulation exercise for logging onto the system by using the security token mechanism and submission of documents.
		Testing guide and testing files will be made



		available in a designated web corner on the HKEXnews website (<u>http://www2.hkexnews.hk/Listed-Company-</u> <u>Publications/Enhanced-ESS</u>) (the "Enhanced ESS Web Corner") in due course.
Q3 – Q4 2019	ESS User Migration	There will be a 5-month transitional period during which ESS users will be migrated in batches to the enhanced ESS. This is to ensure that there will be sufficient lead time for ESS users to familiarise themselves with the enhanced system operations.
		Impact on listed issuers: Migration to the enhanced ESS is mandatory to all ESS users. A separate letter will be issued to the ESS Authorised Persons advising the details of the migration arrangements one month before the migration.
		Please also refer to the Enhanced ESS Web Corner for further updates on the migration schedule for each batch of ESS users.
Before the assigned migration date (as published on the Enhanced ESS Web Corner)	User Account Review and Update	With the introduction of security tokens, a One-Time Password will be sent to the registered mobile number of the ESS users via SMS.
		Impact on listed issuers: Every ESS user is required to provide his/her mobile number by updating the "Mobile No." field in the user profile of ESS (click " <i>My</i> <i>Profile</i> " after logging into the existing ESS). Please also review the user particulars in your user profile to ensure that the information is up-to-date.
