## Re: Invitation to Attend Free Training on ESG Reporting

In 2015, the Exchange published consultation conclusions to upgrade some of the provisions in the Environmental, Social and Governance ("**ESG**") Reporting Guide (the "**Guide**") (Appendix 27 of the Main Board Rules and Appendix 20 of the GEM Rules) to "comply or explain". The amendments to the Guide and related Listing Rules are coming into effect in two phases:

- the Rule amendments and the upgrade of the General Disclosures in the Guide from recommended to "comply or explain", as well as the revised recommended disclosures, become effective for issuers' financial years commencing on or after 1 January 2016; and
- the upgrade of the Key Performance Indicators in the "Environmental" Subject Area of the Guide from recommended to "comply or explain" will be effective for issuers' financial years commencing on or after 1 January 2017.

To enable a better understanding of the revised Guide and to provide practical training on ESG reporting, we will organise 12 two-hour training seminars in March this year. The seminars will feature speakers from the Exchange's Listing Department, as well as ESG specialists and listed company representatives who will provide more in-depth and practical training on ESG reporting. We encourage your directors, authorised representatives, company secretaries and/or ESG managers to attend the seminar.

Each seminar will offer general guidance that is applicable to all issuers, and will also provide industry-specific training. Issuers are, as such, encouraged to register a session that is most relevant to their industries. Confirmation of attendance can be provided to participants upon request.

Seats are limited and will be on a first-come, first-served basis. Each issuer may register up to two attendees for each seminar.
