- (i) Director's / Supervisor's Declaration and Undertaking (DU003M/ DU003G/ DU004M/ DU004G/ DU005M/ DU005G);
- (ii) Contact Details Form For Director / Supervisor / Authorised Representatives / Company Secretary / Compliance Officer (GEM only) (FF004);
- (iii) Formal Application (For Equity Securities) (Form C1 for Mainboard) (FFD001M);
- (iv) Application Form Equity Securities (of an issuer part of whose share capital is already listed) (Form B for GEM) (FF201G);
- (v) Size Tests for Notifiable Transactions and Connected Transactions (CF006);
- (vi) Trading Arrangement Form (CF093);
- (vii) Blackout Period Notification Form (FF005)
- (viii) Listing Application Form (Main Board Form A1 (M103)/ GEM Form 5A (G103));
- (ix) New Listing Particulars (M201/G201);
- (x) Sponsor Engagement Notification (SE001); and
- (xi) New Listing Particulars Debt Securities (DS001)
