## Notice to Issuers – Launch of Meeting Notification e-Form

Listed issuers and market practitioners are advised that the Exchange will introduce the following e-Form:

(1) **e-Form** relating to meeting notification (collectively, **relevant corporate actions**):

• Meeting Notification e-Form (IF001)

Listed issuers are required under the CCASS stock admission requirement to complete and submit the Meeting Notification e-Form through the e-Submission System **(ESS)** on the same day when the notice of meeting is published by the issuer.

As set out in the Consultation Paper on Proposals to Introduce a Paperless Listing & Subscription Regime, Online Display of Documents and Reduction of the Types of Documents on Display published in July 2020, we are introducing this e-Form to standardise the presentation of routine information and to reduce the risk of manual input error through the use of data validation in the e-Form. This will also assist the Exchange in collecting and analysing data more efficiently.

The e-Form will be available for download and submission at the e-Submission System (**ESS**) from **18:00 on 11 July 2021**. To facilitate your planning and preparation for the implementation, please find below the implementation timetable and guidance materials available on HKEX website:
