Distribution of HSI Index Options OI in Month-end

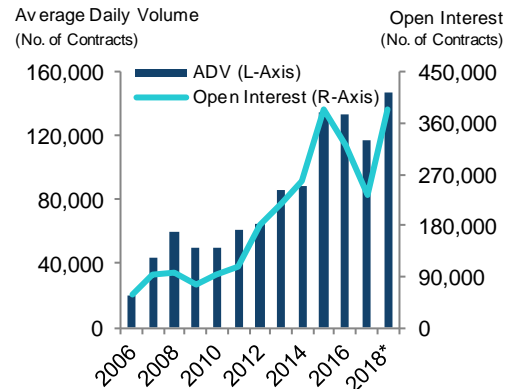

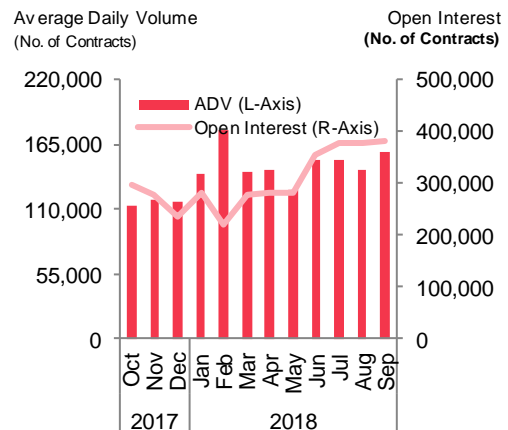

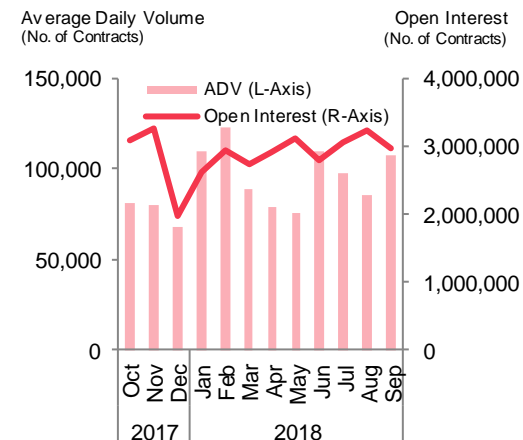

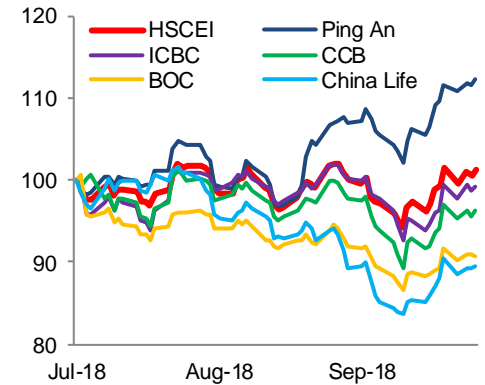

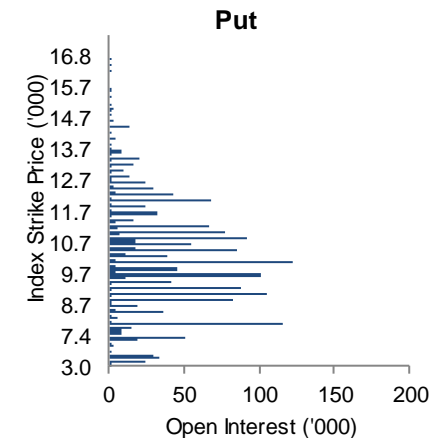
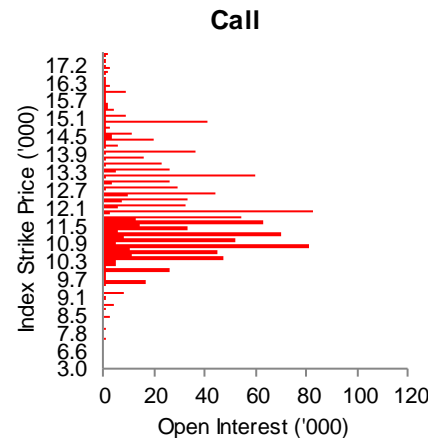
HSI vs HSCEI

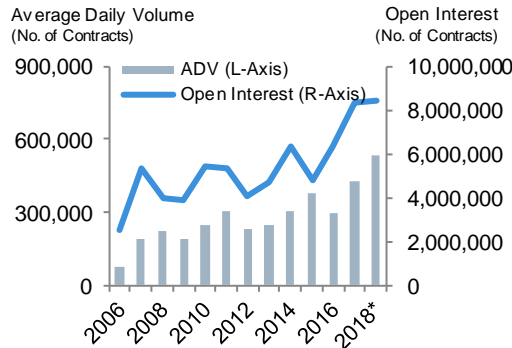

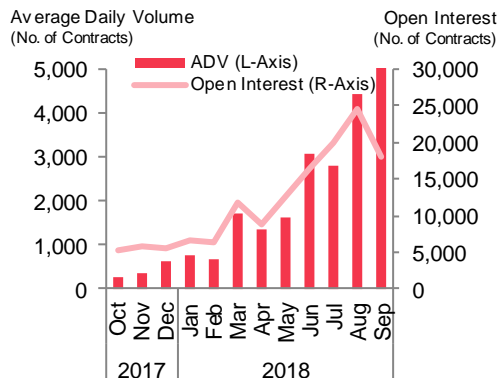

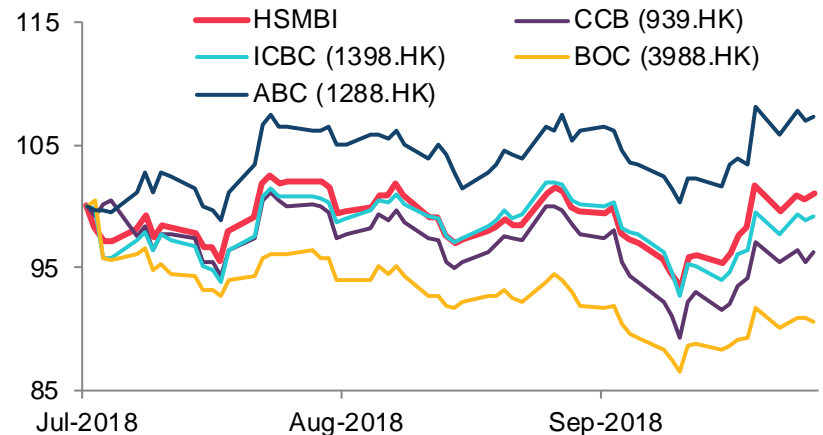

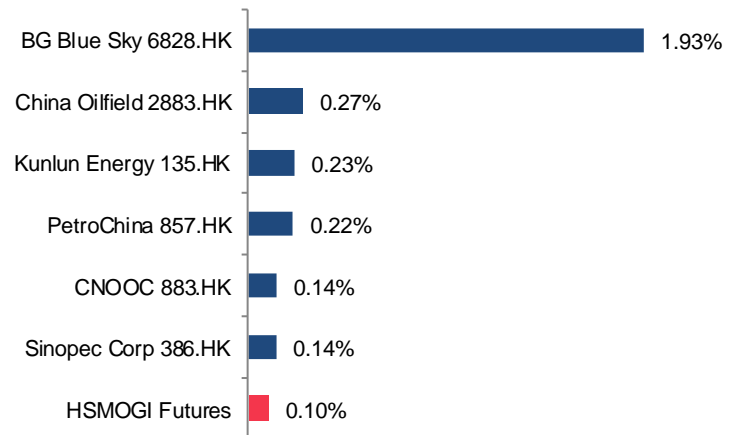

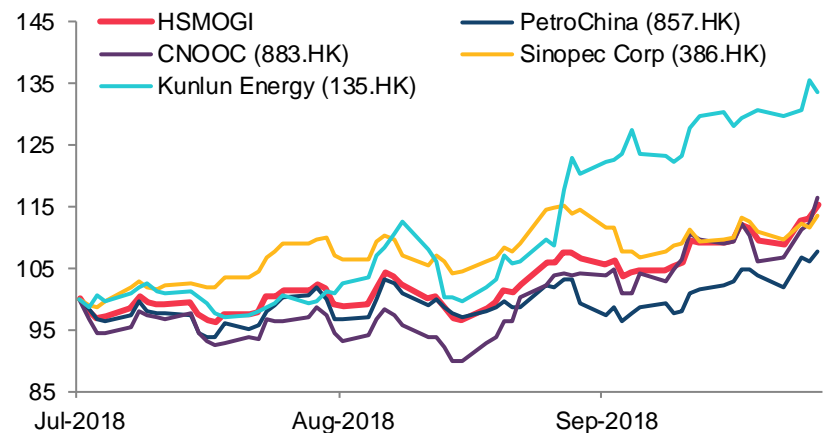

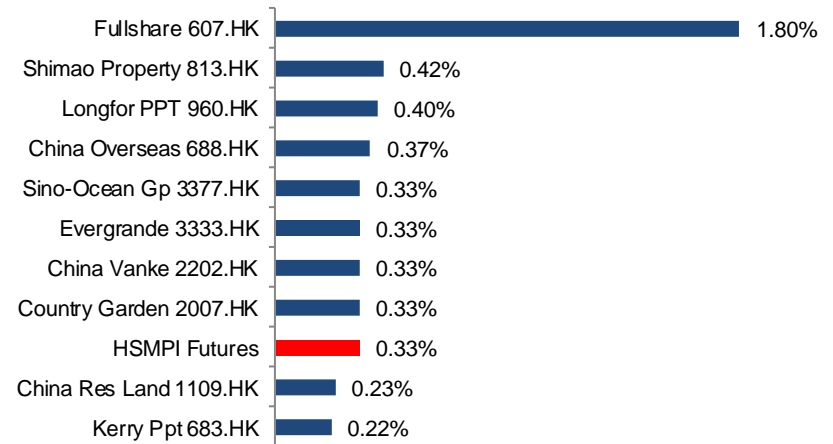

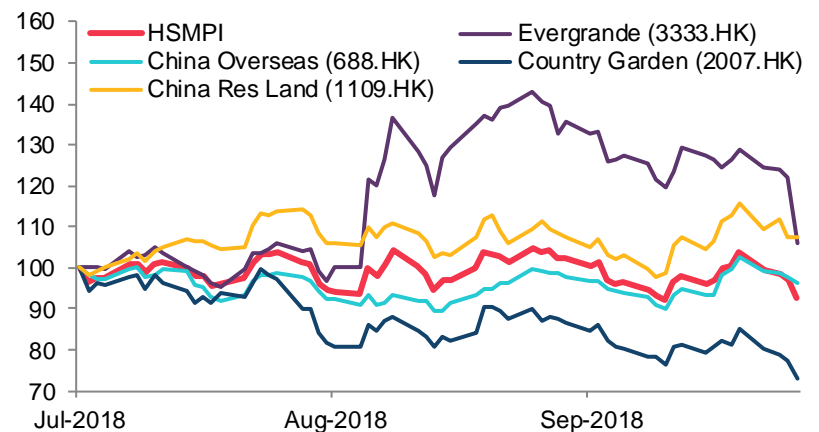

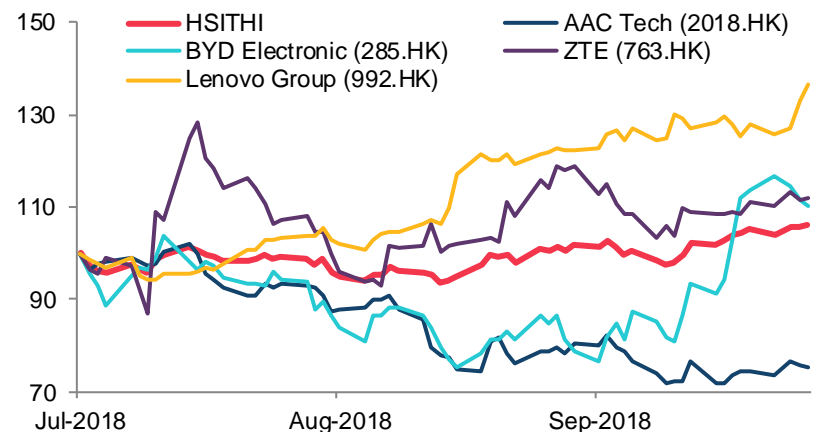
