Market Overview:

- From 19 Oct to 30 Oct 2015, the Northbound Average Daily Buy and Sell Trade Value was RMB4,843 million while the Southbound Average Daily Buy and Sell Trade Value was HK\$1,518 million
- As of 30 Oct 2015, the Northbound Aggregate Quota Usage was RMB137.2 billion while the Southbound was RMB89.1 billion






