For the proposed new Rule 9.11(24), "director's written confirmation"should be revised to "the written confirmation from the listing applicant's directors"

For the proposed new Rule 9.11(25), the written confirmation should not be given by a duly authorized officer of each of such corporate shareholder. As it may not be easy to secure the cooperation from the corporate shareholder to provide the information required, I suggest that this confirmation could be given by the directors (to their best knowledge and belief) of the listing applicant.
