We agree in principle. However, we would respectfully suggest the Exchange to clarify whether the requirement (the "Minimum Training Requirement") would apply to First-time Directors with professional backgrounds and/or

qualifications (such as Certified Public Accountants, Lawyers and Chartered Secretaries) (“Professional First-time Directors”).

Given that the Professional First-time Directors: (i) would already need to satisfy continuous professional development requirements for their respective professions; (ii) would be familiar with corporate governance, ESG, risk management and internal control standards; and (iii) would be attending/have the opportunity to attend continuous professional development courses which covers similar topics, imposing the Minimum Training requirement on them may be redundant and burdensome.

In light of the foregoing, the Exchange may consider providing relevant exemptions for the Professional First-time Directors such that they would not be required to comply with the Minimum Training Requirements.
