I am an investor from mainland China. Under current situation with increasingly cheating behavior in market, I think that HKEX is not trustworthy enough in regulation individually, and SFC's getting involved is a feasible way to recover investor's confidence. So, I hope Plan B will be implemented that SFC should be in charge of listing affairs. Thank you.
