We support the reform proposals, including the formation of the Listing Policy Committee and the Listing Regulatory Committee, as a step towards the efficient market which Hong Kong and investors deserve. The conflicts of interest inherent in having regulatory functions under a for-profit entity are very apparent and very damaging. Maintenance of an efficient disclosure regime and comprehensive library and institutional memory are matters of public interest and should receive more attention.
