Subject: Change of Authentication for CCMS Terminal – Kicking off Email Registration

Reference is made to the circular dated 31 October 2022 (Reference: [CD/OEC/HKCC/303/2022](#)). Clearing Participants (CPs) should have read through the Information Package published on [HKEX website](#) and understand the planned changes on the authentication for CCMS Terminal access from smartcard access to Two-Factor Authentication (2FA) and the related migration plan.

To embark with the migration to 2FA, HKCC is pleased to announce that CPs can start the registration of the designated email address of their users from 19 December 2022 (Monday). The CCMS Delegated Administrators (DAs) can access Security Management Functions (DMS) of CCMS via URL <https://www.ccass.com/dms> and register the designated email address of their users.

It is an important step for authentication for user setup of his/ her regular password to initiate the 2FA. Therefore, email registration is mandatory for each user regardless of the generation of One-Time-Password arrangement either in mobile application or via email. The information package have been enriched with details of the preparation of parallel run, DAs can refer to section 3.1 “Pre-parallel Run – Email Registration” and Appendix A “Email Registration Procedure for Users” of the document for the update in DMS and the step by step email registration procedure.

DAs are advised to focus on updating the email address of their users before the start of parallel run. It is not necessary to register the email address of DAs for the time being and their registration will be kicked off in early 2023. A summary of the upcoming events and tentative schedule is recapped below for reference:

Late Q2 2023	<ul style="list-style-type: none"><li>• End of parallel run, i.e. access to CCMS Terminal with 2FA only</li><li>• Decommissioning of smartcard authentication method</li></ul>
