Clearing Participants ("CPs") are currently having DCASS Administrator Users to manage passwords and access rights of their DCASS Online users. To further enhance the security assurance for DCASS Administrator Users (i.e. "BU\_CXXX20x"), the password complexity requirement will be tightened effective from 1 December 2022.

The tightened password complexity requirement of DCASS Administrator Users are listed below:
