Subject: Change of Authentication for CCMS Terminal – (i) Reminder of email registration for

CCMS users; (ii) Kick-off of email registration for CCMS Delegated Administrators

Reference the circular dated 14 December 2022 (Reference: is made to CD/OEC/HKCC/342/2022). At the start of the parallel run, when users set their regular passwords to enable Two-Factor Authentication (2FA), their email addresses will be used for authentication. Therefore, it is important for each user to have email registered with HKCC for the regular Users can choose to obtain the One-Time-Password (OTP) via mobile application or email as 2FA after the regular password setup. CCMS Delegated Administrators (DAs) of Clearing Participants (CPs) must register the designated email addresses of their users for the 2FA migration via Security Management Functions (DMS) of CCMS by 28 April 2023 (Friday). Failure to register a user's email address by the above-mentioned date will prevent that user from initiating 2FA to access to CCMS Terminal at the start of the parallel run. For details of the email registration and 2FA login procedure, please refer to Appendix A and B of the Information Package published in December 2022 on HKEX website.
