Holders of Futures Exchange Trading Rights and Exchange Participants are requested to note that the Securities and Futures Commission has approved amendments to the HKFE Rules for the purpose of extending the closing hour of the after-hours trading session of certain stock index futures, stock index options, metal futures and currency futures contracts to 3:00 a.m.

The amendments, as set out in the Appendix, will come into effect on Monday, 17 June 2019.
