The Panel Member Selection Committee (“the Committee”) is pleased to invite nominations from Participants of the stock and futures exchanges (“Exchange Participants”) and their respective clearing houses (“Clearing Participants”) of suitable candidates to the Consultative Panels for consideration and approval.

The Consultative Panels act as the advisory bodies to the HKEX Board to provide market expertise and advice on international market trends, the needs of intermediaries, issuers, investors and other market participants, technological challenges and new product opportunities relating to the Cash Market, Derivatives Market and clearing business. Each of the Consultative Panels consists of two directors of HKEX and eight/nine members selected from representatives of market participants and industry experts. Details of the role and functions of each of the Consultative Panels are set out in their respective terms of reference which are available on the HKEX Group website at [https://www.hkexgroup.com/Corporate-Governance/Corporate-Governance-Framework/Corporate-Governance-Practices/Consultative-Panels/Terms-of-reference?sc\\_lang=en](https://www.hkexgroup.com/Corporate-Governance/Corporate-Governance-Framework/Corporate-Governance-Practices/Consultative-Panels/Terms-of-reference?sc_lang=en).

Candidates nominated to the Consultative Panels should be a member of the senior management in the Exchange Participant’s or the Clearing Participant’s business and should have a good knowledge of, and expertise in, the relevant market and business. Meetings will be held as the work of the panel demands and members are expected to attend all the meetings in person or by submission. Appointing an alternate member to attend meetings is not allowed.

Selected candidates will be appointed in their personal capacity and their terms of appointment will be for a term of not more than three years commencing June 2019.

**An Exchange Participant or a Clearing Participant is entitled to make only one nomination to one relevant panel. Nevertheless, an Exchange Participant who is a participant of The Stock Exchange of Hong Kong Limited, Hong Kong Futures Exchange Limited and their respective clearing houses is entitled to make one nomination to each of the Consultative Panels.**

Nominations should be made in the prescribed form as attached.
