Subject: 2020 Annual Attestation and Inspection Programme - Self-attestation of

Compliance Questionnaire

Reference is made to the circular (Ref. No.: MSM/002/2020) dated 28 February 2020 regarding the Annual Attestation and Inspection Programme 2020 (the "Programme"). Under the Programme, all Participants are required to submit a duly completed Self-attestation of Compliance Questionnaire (the "Questionnaire") via the Electronic Communication Platform¹ (the "ECP") at https://www.ecp.hkex.com.hk/.

The Questionnaire is divided into two parts. Participants are required to complete and return the relevant parts to the Exchange by the submission deadline, which has been extended this year in view of the COVID-19 outbreak.

- Part 1 covers China Connect Rules and Client Margin Requirements. Exchange Participants² are required to complete and return the Questionnaire by 12 June 2020.
- Part 2 covers Risk Management and is applicable to Clearing Participants only³. A separate circular will be published in due course.

The Questionnaire and the User Guide for the ECP are available at HKEX Rule Enforcement's webpage.
